20 Whereas the Attorney General of the State of Florida (“Attorney General”) filed a Complaint
21 in the above-captioned case against Samsung Electronics Co., Ltd., Samsung Electronics America,
22 Inc., and Samsung Semiconductor Inc. (collectively “Samsung”), among other defendants, on August
23 11, 2010 (“Complaint”);

24 Whereas on August 16, 2010, Samsung stipulated to service of process in exchange for an
25 extension of its time to respond to the Complaint until October 15, 2010.

26 Whereas the Attorney General subsequently entered into a stipulation with other Defendants
27 extending their deadline to move to dismiss, answer, or otherwise respond to the Complaint until
28 December 14, 2010; and

2 Whereas the Attorney General and Samsung believe that proceeding on a unified response
3 date will create efficiency for the Court and the parties by reducing duplicative motion practice;

5 Therefore, the Attorney General and Samsung hereby agree:

7 1. Samsung's deadline to move to dismiss, answer, or otherwise respond to the
8 Complaint will be December 14, 2010.
