**GOOGLE'S COMMENTS ON THE
COURT'S DESCRIPTION OF JAVA
LANGUAGE PRINCIPLES**

1 Google provides the following comments on the Court's draft description of Java
2 language principles. All of Google's comments are in the nature of minor corrections to the
3 Court's text or correction of typographical errors:

4 Page 1, line 1: "Java punctuation" should be changed to "Java syntax"

5 Page 1, lines 4-5: "each statement being a single command" should be changed to "each
6 statement being one or more commands"

7 Page 1, line 17: "output(s)" should be changed to "output"; "are" should be changed to
8 "is"; and "return(s)" should be changed to "return" – so the sentence should read "The output
9 from the method is known as the return."

10 Page 2, line 11: "method body mut [sic] have" should be changed to "method body **must**
11 have"

12 Page 2, line 17: "Java" should be changed to "J2SE"

13 Page 3, line 2: "patent class" should be changed to "parent class"

14 Page 3, line 11: the final curly bracket should be facing in the opposite direction – it
15 should be a close bracket rather than an open bracket.

16 Google does not propose any additions to the Court's description.

17 Google has received through the CM-ECF system Oracle's suggested changes to the
18 Court's draft. (Dkt. 1110). Google will review Oracle's suggestions and will be prepared to
19 comment on them tomorrow morning.
