2	STIPULATION		
3	WHEREAS, the Court's order of November 14, 2011 (Dkt. No. 617) required that Oracle		
4	designate three interviewees for deposition, and that those three depositions be completed by		
5	November 22, 2011; and		
6	WHEREAS, on November 15, 2011, Oracle informed Google that it wanted to take the		
7	depositions of Timothy Bray, John Rizzo, and Dan Bornstein; and		
8	WHEREAS, on November 16, 2011, Google offered Mr. Bornstein for deposition on		
9	Monday, November 21, 2011; and		
10	WHEREAS, on November 17, 2011, Oracle accepted that offer and agreed take Mr.		
11	Bornstein's deposition on November 21, 2011; and		
12	WHEREAS, prior to the Court's November 14, 2011 order, the parties had scheduled the		
13	interviews of Google employee Timothy Bray and third party John Rizzo for November 30, 2011		
14	and		
15	WHEREAS, Mr. Bray is currently traveling in Asia and will not be returning to the United		
16	States until after the Court's deadline of November 22, 2011; and		
17	WHEREAS, because Mr. Rizzo is not a Google employee, his day-to-day availability for		
18	proceedings in this case is not subject to Google's control, but Mr. Rizzo had voluntarily agreed		
19	to accept service of a deposition subpoena and sit for deposition on November 30, 2011, and		
20	Oracle had issued a deposition subpoena to Mr. Rizzo for that date; and		
21	WHEREAS, accordingly, on November 16, 2011, Google proposed to Oracle that, subject		
22	to Court approval, the depositions of Mr. Bray and Mr. Rizzo should take place on the previously		
23	agreed date of November 30, 2011; and		
24	WHEREAS, on November 17, 2011, Oracle agreed to accommodate Mr. Bray's and Mr.		
25	Rizzo's schedules by deposing those witnesses on November 30, 2011; and		
26	WHEREAS, the parties acknowledge and agree that a limited extension of time to depose		
27	Mr. Bray and Mr. Rizzo will not affect, delay, or push back any other deadlines in this case or		
28	cause any prejudice to either Google or Oracle.		

NOW THEREFORE THE PARTIES HEREBY STIPULATE AND AGREE that:

- 1. The deadline for completing the depositions of Timothy Bray and John Rizzo should be extended from November 22, 2011 to November 30, 2011.
- 2. No other deadlines in this case will be affected by the foregoing extension. The parties will not use this extension to argue for a delay of any other deadlines in this case.
