1 Pursuant to the Court's November 19, 2010 Case Management Order (Dkt. No. 56), a
2 form of protective order was to be submitted by December 10, 2010. The parties met and
3 conferred in good faith and reached agreement on all but two issues: whether any in-house
4 counsel would have access to information of the highest designation, and whether a prosecution
5 bar would attach to persons accessing designated information. The parties respectfully request
6 the Court's assistance in resolving these issues. Attached as Exhibit A is Oracle America, Inc.'s
