**ORDER OF DISMISSAL**

14 Plaintiff, a prisoner of the State of California, filed this pro se civil rights action  
15 under 42 U.S.C. § 1983. On August 25, 2010, the same day the complaint was filed, the  
16 Clerk notified Plaintiff that he had neither paid the filing fee nor filed an application to  
17 proceed in forma pauperis (“IFP”). Along with the notice, the Clerk mailed to Plaintiff  
18 the Court’s IFP forms, instructions for completing the forms, and a stamped return  
19 envelope. In the notice, Plaintiff was informed that the case would be dismissed if he did  
20 not either pay the fee or file a completed IFP application within thirty days. Plaintiff has  
21 neither paid the filing fee nor filed an IFP application within the allotted time, nor has he  
22 explained his failure to do so. Accordingly, this case is **DISMISSED** without prejudice.  
23 *See* Fed. R. Civ. P. 41(b).

24 The Clerk shall enter judgment and close the file.

25 IT IS SO ORDERED.
