18 Defendant HOME DEPOT U.S.A., INC. ("Defendant") and Plaintiff JOY SCHOLTZ
 19 ("Plaintiff") have engaged in good faith meet and confer efforts regarding their previous
 20 stipulation to participate in the ADR process. Pursuant to the Court's December 1, 2010 order
 21 (Pacer docket #7), the present deadline to complete the ADR process is March 1, 2011.

22 Medical records necessary to the evaluation of this matter are currently pending
 23 production from the medical provider. Counsel has been informed that the production date is
 24 expected within 60 days of the date of this filing. The Parties and the mediator in this matter
 25 have met and conferred and have agreed to a new mediation date of May 5, 2011.

26 As the outstanding medical records are necessary to fully evaluate the claimed damages
 27 in advance of the mediation process, Plaintiff and Defendant hereby stipulate and respectfully
 28 request that the Court continue the deadline to complete the ADR process to May 12, 2011. In

1 addition, the Parties hereby stipulate and agree and respectfully request that the Court continue
2 the deadline to file and exchange Initial Disclosures to March 1, 2011.

3 **NOW, THEREFORE**, the Parties hereby stipulate and agree that, subject to the Court's
4 approval:

- 5 1. The deadline to complete the ADR process presently set for March 1, 2011 is
- 6 continued to May 12, 2011.
- 7 2. Initial Disclosures shall be filed and exchanged March 1, 2011.
