 31 representative to appear at the March 6, 2012 Settlement Conference by telephone, this Court

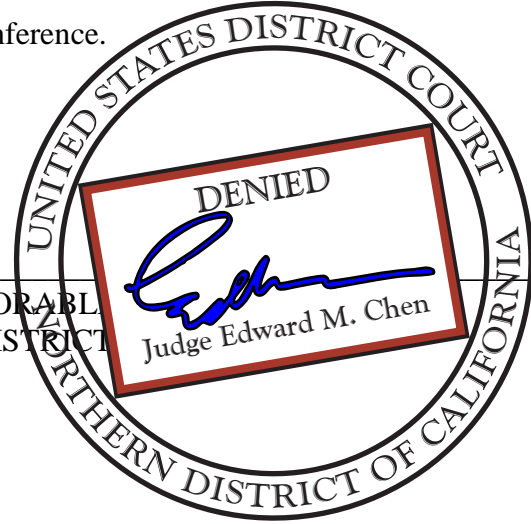
1 GRANTS UNUM's request and orders as follows:
