21 Plaintiff JULIE CARLSON (hereinafter "Plaintiff"), and Defendant ANKA
 22 BEHAVIORAL HEALTH, INC. (hereinafter "Anka"), by and through their attorneys of
 23 record, pursuant to Local Rules 6-2 and 7-12, do hereby stipulate and agree that the time for
 24 Anka to respond to Plaintiff's Second Amended Complaint in the above-referenced action
 25 shall be extended up to and including **June 14, 2011**.

26 Plaintiff moved the Court on April 13, 2011 for Leave to Amend to File a Second
 27 Amended Complaint with a hearing date of May 23, 2011. Anka filed a Non-Opposition to
 28 Plaintiff's Motion for Leave to Amend on May 2, 2011. On May 4, 2011, the Court granted



1 Plaintiff's request to file a Second Amended Complaint and ordered it filed no later than May
2 9, 2011, with a responsive pleading due on Anka's behalf, on or before May 31, 2011.

3 Plaintiff did not file the Second Amended Complaint until May 24, 2011, thus, in light
4 of this delay, the parties have agreed to extend Anka's time to submit its responsive pleading
5 to June 14, 2011.

6 The parties do not believe that this extension of time for Anka to file a responsive
7 pleading to the Second Amended Complaint, will delay the schedule for the case.
