22 IT IS HEREBY STIPULATED by and between Defendant ANKA BEHAVIORAL

10 discovery and prepare for and attend the upcoming settlement conference.

11 The Parties also request that all related dates, be continued as well in relation to the new
12 Case Management Conference hearing date.
