 23 **INTRODUCTION**

24 Plaintiff is a former Safeway employee who was terminated in January
 25 2010 for violating company policies. In this action, he alleges that his
 26 termination was the result of racial discrimination and that his Union breached
 27 its duty of good faith and fair dealing during post termination grievance

1 proceedings.

2 This case is scheduled for a Further Case Management Conference on
3 January 13, 2012. The parties recently reached a tentative settlement in this
4 case and have agreed to stipulate to an Order from the Court continuing the


