22 RECITALS

- 23 1. On September 21, 2010, Plaintiff filed its Complaint with this Court.
24 2. Defendant was served with the Summons and Complaint on September 22, 2010.
25 3. Pursuant to the Summons, Defendant's response must be filed twenty-one days
26 after service, which is October 13, 2010.
27 4. Local Rule 6-1 provides that parties may stipulate in writing, without a Court order,
28 to extend the time within which to answer or otherwise respond to the complaint, provided the

2 5. The parties agree that a thirty-day extension of the time that Defendant has to
3 answer or otherwise respond to the Complaint is appropriate and that such an extension will not
4 alter the date of any event or any deadline already fixed by Court order.

5 STIPULATION

6 1. Plaintiff and Defendant hereby stipulate and agree that the time for Plaintiff to file
7 its answer or otherwise respond to the Complaint shall be extended for thirty days, from October
8 13, 2010 to November 12, 2010.
