 20 Plaintiff Cutting Edge Audio Group, LLC d/b/a Cutting Edge Audio and  
 21 Video Group (hereinafter "Plaintiff"), on the one hand, and Defendant Cutting Edge  
 22 Technology (hereinafter "Defendant"), on the other hand, through their counsel of  
 23 record hereby stipulate and agree as follows:

24 RECITALS

- 25 1. On September 21, 2010, Plaintiff filed its Complaint with this Court.  
 26 2. Defendant was served with the Summons and Complaint on September  
 27 22, 2010.  
 28 3. Pursuant to the Summons, Defendant's response originally had to be

1 filed twenty-one days after service, which was October 13, 2010.

2 4. On October 11, 2010, the parties filed a stipulation to extend time of  
3 Defendant to respond to the complaint. On October 18, 2010, the Court issued an  
4 Order granting the parties' stipulation, thereby allowing Defendant until November  
5 12, 2010 to respond to Plaintiff's complaint.

6 5. The parties are currently engaged in settlement negotiations aimed at  
7 resolving this case in its entirety. The parties want to continue to focus their  
8 energies on their settlement negotiations over the next two weeks, and wish to  
9 conserve resources and expenditures on the case in the meantime.

10 6. For reasons stated above, the parties agree that a short additional  
11 extension of the time that Defendant has to answer or otherwise respond to the  
12 Complaint is appropriate and that such an extension will not alter the date of any  
13 event or any deadline already fixed by Court order.



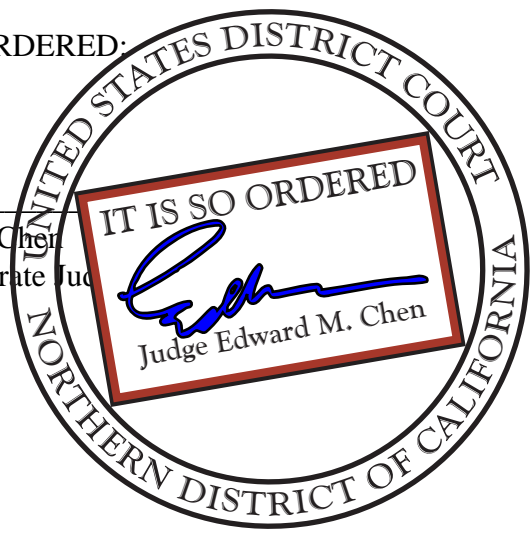
