The parties hereby stipulate as follows:

1. Plaintiff Louis M. Binaley ("plaintiff") hereby stipulates and requests that the Court dismiss the present action in its entirety, without prejudice, pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii);

1           2.       AT&T Umbrella Benefit Plan No. 1 (the "Plan") stipulates and agrees that  
2 plaintiff is permitted to file an administrative appeal of the denial of his claim for long term  
3 disability benefits (the "administrative appeal"), and that the Plan shall perform a full and fair  
4 review of the appeal in accordance with the applicable provisions of the Employee Retirement  
5 Income Security Act of 1974 ("ERISA"), 29 U.S.C. §§ 1001, et seq. and the applicable federal  
6 regulations promulgated thereunder;

7           3.       Plaintiff agrees to file his administrative appeal and submit all medical  
8 documentation for the time period November 2008 to the present in support of the administrative  
9 appeal within 60 days of the effective date of the Order herein. The Plan shall make its  
10 determination on the administrative appeal within 60 days from the date Plaintiff submits all his  
11 medical documentation.

12           4.       The Plan stipulates and agrees that any statutes of limitation or other time  
13 limitations otherwise applicable to plaintiff's claims are tolled during the pendency of the appeal,  
14 and the running of any applicable limitation period will resume when a final determination is  
15 rendered on the administrative appeal. Plaintiff will not be barred from filing a timely civil  
16 action thereafter.
