ORDER

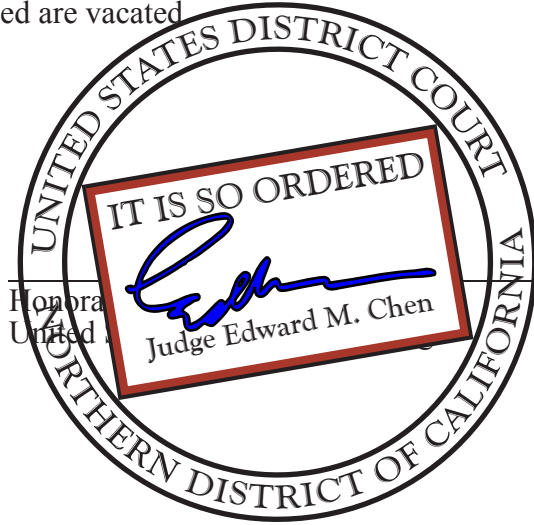
Pursuant to stipulation of the parties through their counsel of record, and for good cause, IT IS HEREBY ORDERED THAT:
