6 The undersigned counsel, on behalf of Plaintiffs Best Buy Co., Inc., Best Buy Purchasing
7 LLC, Best Buy Enterprise Services, Inc., Best Buy Stores, L.P., and Magnolia Hi-Fi, Inc.
8 (collectively, "Plaintiffs"), and Defendant Chunghwa Picture Tubes, Ltd. ("Chunghwa") hereby
9 stipulate and agree as follows:

10 WHEREAS, Plaintiffs filed a Complaint in the above-captioned case against Defendant
11 Chunghwa and other defendants, on October 8, 2010;

12 WHEREAS, on March 8, 2011, the Court granted Plaintiffs' motion to serve Chunghwa
13 through its U.S. counsel pursuant to Federal Rule of Civil Procedure 4(f)(3);

14 WHEREAS, in light of that Order, the parties agree that such service may occur via email to
15 counsel but that such agreement does not constitute a waiver of Chunghwa's objection to service of
16 the complaint and summons through U.S. counsel;

17 WHEREAS, Plaintiffs and Chunghwa have reached an agreement, pursuant to Civil L.R. 6-
18 1(a), to extend the time within which Chunghwa must move against, answer or otherwise respond to
19 Plaintiffs' Complaint;

20 WHEREAS, this extension will not alter the date of any event or any deadline already fixed
21 by the Court; and

22 WHEREAS, the Court has previously approved stipulations between Plaintiffs and certain
23 other defendants extending those defendants' time to dismiss, answer, or otherwise respond to the
24 Complaint until May 10, 2011;

25 THEREFORE, the time within which Chunghwa must answer Plaintiffs' Complaint is
26 extended until May 10, 2011; this stipulation applies exclusively to the time for Chunghwa to answer,
27 but not to move against or otherwise respond to the Complaint.
