The parties' stipulated request herein is not made for purposes of delay or harassment, but is based in good faith upon the grounds stated above. For these reasons, the parties respectfully request an Order from this Court continuing the date for the Case Management Conference from February 23, 2012 at 10 a.m. to March 1, 2012 at 10 a.m. 1:30 p.m.
