14 Pursuant to Rule 16(b) of the Federal Rules of Civil Procedure, the parties attended a Case
15 Management Conference on March 22, 2012. After considering the Joint Case Management
16 Statement submitted by the parties and consulting with the attorneys of record for the parties and
17 good cause appearing, IT IS HEREBY ORDERED THAT:

18 1. DISCOVERY. On or before October 26, 2012, all non-expert discovery shall be
19 completed by the parties. Discovery shall be limited as follows: (a) ten (10) non-expert depositions
20 per party; (b) twenty-five (25) interrogatories per party, including all discrete subparts; (c) a
21 reasonable number of requests for production of documents or for inspection per party; and (d) a
22 reasonable number of requests for admission per party.

23 2. EXPERT WITNESSES. The disclosure and discovery of expert witness opinions
24 shall proceed as follows:

25 A. On or before November 15, 2012, plaintiffs shall disclose expert testimony reports in
26 accordance with Federal Rule of Civil Procedure 26(a)(2).

27 B. On or before November 30, 2012, defendants shall disclose expert testimony and reports
28 in accordance with Federal Rule of Civil Procedure 26(a)(2).

CASE MANAGEMENT SCHEDULING ORDER

1 C. On or before December 21, 2012, all discovery of expert witnesses pursuant to Federal
2 Rule of Civil Procedure 26(b)(4) shall be completed.

3 3. FURTHER CASE MANAGEMENT CONFERENCE. A Further Case Management
4 Conference shall be held on **July 19, 2012 at 10:00 a.m.** in Courtroom 3, 17th Floor, United States
5 Courthouse, 450 Golden Gate Avenue, San Francisco, California. The parties shall file a Joint Case
6 Management Statement at least one week prior to the Conference.

7 4. PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to
8 Civil Local Rule 7. All pretrial motions shall be heard no later than February 21, 2013.

9 5. PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and
10 confer to discuss preparation of a joint pretrial statement, and on or before April 18, 2013, counsel
11 shall file a Joint Pretrial Statement.

12 6. PRETRIAL CONFERENCE. The final pretrial conference will be held on **April 25,**
13 **2013 at 10:00 a.m.,** in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate
14 Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend
15 personally.

16 7. TRIAL DATE. Trial shall commence on **May 13, 2013 at 9:00 a.m.,** in Courtroom
17 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco, California.
