23 Defendant BAYER CROPSCIENCE, INC. ("Bayer CropScience") and Plaintiff
 24 FRANK RICCO ("Plaintiff"), by and through their respective counsel of record, Brydon
 25 Hugo & Parker and Brayton Purcell, L.L.P., AGREE and STIPULATE, subject to the
 26 approval of the Court, that Bayer CropScience and Plaintiff be allowed to move their
 27 currently scheduled Settlement Conference from March 10, 2014 before the Honorable
 28 Joseph C. Spero to March 11, 2014 before the Honorable Jacqueline Scott Corley. Bayer
 CropScience represents that its client representative, Christopher Cruz, is unable to
 personally attend the Settlement Conference on March 10, 2014 as he will be out-of-state
 on a pre-paid trip.

1 On March 11, 2014, Judge Corley is already scheduled to conduct the Settlement
2 Conferences in two other Brayton Purcell cases which Mr. Cruz will be attending in
3 person (for Union Carbide Corp.), *Lyman v. Asbestos Defendants*, 3:07-cv-04240 and *Young*
4 *v. Georgia-Pacific Corporation, et al.*, 3:11-cv-05154. Judge Corley's Deputy has confirmed
5 with Bayer CropScience that Judge Corley has kindly agreed to conduct the *Ricco*
6 Settlement Conference between Plaintiff and Bayer CropScience on March 11, 2014.

7 Alternatively, Bayer CropScience and Plaintiff further AGREE and STIPULATE,
8 subject to the approval of the Court, that Christopher Cruz be allowed to attend the March
9 10, 2014 Settlement Conference via telephone.
