**PETITION AND ORDER FOR
APPOINTMENT OF GUARDIAN AD

20 Defendant MEGAN ROSE, as Mother and Natural Guardian for Matthew Rose, hereby
21 petitions the court for an appointment as Guardian Ad Litem to Matthew Rose, a minor in the
22 above-referenced action and provides the following in support:

- 23 1. Megan Rose is the mother and natural guardian of Matthew Rose, a minor whose birthday
24 is November 16, 1996.
- 25 2. Upon information and belief, on or about February 20, 2008, John A. Rose designated
26 Matthew Rose as a primary beneficiary to a life insurance policy issued by Prudential
27 Insurance Company of America.

- 1 3. Upon information and belief, on February 20, 2008, John A. Rose also executed a
- 2 Beneficiary Designation/Change Form designating Joshua Rose as primary beneficiary of
- 3 the policy.
- 4
- 5 4. On or about June 7, 2010, Megan Rose was granted guardianship over the estates of minor
- 6 Matthew Rose and then minor, Joshua Rose.
- 7
- 8 5. Unable to make a legal or factual determination as to which individual (Matthew or
- 9 Joshua) was entitled to the death benefit under the policy, Prudential Insurance Company
- 10 of America ("Prudential") filed an interpleader action on or about October 25, 2010.
- 11
- 12 6. As part of its action, Prudential requested the court appoint Guardian Ad Litem over each
- 13 minor so they may litigate their respective rights to the death benefit.
- 14
- 15 7. On February 19, 2011, Joshua Rose turned 18 and is no longer a minor.
- 16
- 17 8. There is no dispute between Joshua Rose and Matthew Rose as to how the proceeds of the
- 18 death benefit should be distributed. Joshua Rose agrees to share equally in the benefit with
- 19 Matthew Rose.
- 20
- 21 9. Petitioner, Megan Rose currently resides with both Matthew and Joshua Rose at 3303 La
- 22 Snelva Apt. 3, San Mateo, CA. Matthew Rose suffers from Autism. Ms. Rose is the person
- 23 most knowledgeable regarding his condition and the person most qualified to represent his
- 24 interests.
- 25
- 26 10. Petitioner is a competent and responsible person and consents to act as Guardian Ad Litem
- 27 on behalf of her minor son Matthew Rose for the purpose of representing his interests in
- 28 the distribution of the proceeds of the life insurance policy previously deposited with the
- court by Prudential .


WHEREFORE, Petitioner moves the court for an order appointing her as Guardian Ad
