
16 To Plaintiff, Allstate Insurance Company and all attorneys of record:


6 Declaration of Dotty E. LeMieux in support of telephone appearance

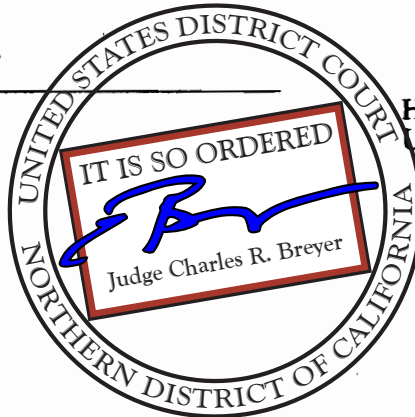
