**STIPULATION AND [PROPOSED]
 ORDER EXTENDING TIME TO MOVE
 TO COMPEL AS TO CERTAIN
 DISCOVERY**

1 Defendant LG Display Co., Ltd. and plaintiffs Target Corp., Sears, Roebuck and Co.,
2 Kmart Corp., Old Comp Inc., Good Guys, Inc., Radioshack Corp., Newegg Inc. (collectively,
3 “Target Plaintiffs”) stipulate as follows:

4 WHEREAS LG Display Co., Ltd. served a set of Requests for Admission and
5 Interrogatories on the Target Plaintiffs on October 31, 2011 (collectively, “Discovery”);

6 WHEREAS several parties, including LG Display and the Target Plaintiffs, stipulated to
7 an extension that provided until January 30, 2012 for the receiving parties to respond and until
8 March 1, 2012 for the propounding parties to move to compel;

9 WHEREAS the Target Plaintiffs served their responses and objections to the Discovery
10 on January 30, 2012;

11 WHEREAS LG Display and the Target Plaintiffs desire additional time to meet and
12 confer to resolve their disputes regarding the Discovery;

13 THEREFORE, LG Display and the Target Plaintiffs, by their respective undersigned
14 counsel, stipulate and agree as follows:

15 The deadline for LG Display to move to compel further response to the Discovery shall be
16 extended to March 16, 2012.
