11 On November 15, 2010, the Court ordered the parties in the above-captioned matter to file  
12 their consents to proceed before a magistrate judge or requests for reassignment to a district judge by  
13 November 29, 2010. Neither party complied with the deadline. This civil case was randomly  
14 assigned to Magistrate Judge James for all purposes including trial. In accordance with 28 U.S.C. §  
15 636(c), the magistrate judges of this district court are designated to conduct any and all proceedings  
16 in a civil case, including trial and entry of final judgment, upon the consent of the parties. An appeal  
17 from a judgment entered by Magistrate Judge James may be taken directly to the United States Court  
18 of Appeals for the Ninth Circuit in the same manner as an appeal from any other judgment of a  
19 district court.

20 You have the right to have your case assigned to a United States District Judge for trial and  
21 disposition. Accordingly, the parties shall inform the court whether they consent to Magistrate  
22 Judge James' jurisdiction or request reassignment to a United States District Judge for trial. The  
23 parties shall inform the Court of their decision by December 16, 2010.
