The Parties hereby provide a status report on efforts to

3 By Order dated March 29, the Court Ordered that Defendants
4 YEE MEI CHEUNG & FAMILY; YEE MEI CHEUNG; TAT CHEUNG; MACIEL
5 CICERO; LAGHAEI FARID; WAI BING CHEUNG; and YOUNG NG YING, who
6 are the owners and landlords of the subject property, be served
7 by a variety of methods, including by publication in the
8 San Francisco Chronicle, service by mail at their last known
9 address, and by including copies of the summons and other initial
10 pleadings with the monthly rent check. All ordered steps have
11 been completed, and proofs are in the process of being filed. As
12 to the publication, the Chronicle published the last required
13 segment on April 30. Plaintiff's counsel represents that he has
14 not yet heard from any party purporting to represent these
15 Defendants. Their responsive pleadings are now due on May 21,
16 2012.


