STIPULATED PROTECTIVE ORDER FOR
 STANDARD LITIGATION

17 1. PURPOSES AND LIMITATIONS

18 Disclosure and discovery activity in this action are likely to involve production of confidential,
 19 proprietary, or private information for which special protection from public disclosure and from use for
 20 any purpose other than prosecuting this litigation may be warranted. Accordingly, the parties hereby
 21 stipulate to and petition the court to enter the following Stipulated Protective Order. The parties
 22 acknowledge that this Order does not confer blanket protections on all disclosures or responses to
 23 discovery and that the protection it affords from public disclosure and use extends only to the limited
 24 information or items that are entitled to confidential treatment under the applicable legal principles. The
 25 parties further acknowledge, as set forth in Section 12.3, below, that this Stipulated Protective Order does
 26 not entitle them to file confidential information under seal; Civil Local Rule 79-5 and General Order 62 set
 27 forth the procedures that must be followed and the standards that will be applied when a party seeks
 28 permission from the court to file material under seal.

1 2. DEFINITIONS

2 2.1 Challenging Party: a Party or Non-Party that challenges the designation of information or
3 items under this Order.

4 2.2 “CONFIDENTIAL” Information or Items: information (regardless of how it is generated,
5 stored or maintained) or tangible things that qualify for protection under Federal Rule of Civil Procedure
6 26(c).

7 2.3 Counsel (without qualifier): Outside Counsel of Record and House Counsel (as well as
8 their support staff).

9 2.4 Designating Party: a Party or Non-Party that designates information or items that it
10 produces in disclosures or in responses to discovery as “CONFIDENTIAL.”

11 2.5 Disclosure or Discovery Material: all items or information, regardless of the medium or
12 manner in which it is generated, stored, or maintained (including, among other things, testimony,
13 transcripts, and tangible things), that are produced or generated in disclosures or responses to discovery in
14 this matter.

15 2.6 Expert: a person with specialized knowledge or experience in a matter pertinent to the
16 litigation who has been retained by a Party or its counsel to serve as an expert witness or as a consultant in
17 this action.

18 2.7 House Counsel: attorneys who are employees of a party to this action. House Counsel
19 does not include Outside Counsel of Record or any other outside counsel.

20 2.8 Non-Party: any natural person, partnership, corporation, association, or other legal entity
21 not named as a Party to this action.

22 2.9 Outside Counsel of Record: attorneys who are not employees of a party to this action but
23 are retained to represent or advise a party to this action and have appeared in this action on behalf of that
24 party or are affiliated with a law firm which has appeared on behalf of that party.

25 2.10 Party: any party to this action, including all of its officers, directors, employees,
26 consultants, retained experts, and Outside Counsel of Record (and their support staffs).

27 2.11 Producing Party: a Party or Non-Party that produces Disclosure or Discovery Material in
28 this action.

1 2.12 Professional Vendors: persons or entities that provide litigation support services (e.g.,
2 photocopying, videotaping, translating, preparing exhibits or demonstrations, and organizing, storing, or
3 retrieving data in any form or medium) and their employees and subcontractors.

4 2.13 Protected Material: any Disclosure or Discovery Material that is designated as
5 “CONFIDENTIAL.”

6 2.14 Receiving Party: a Party that receives Disclosure or Discovery Material from a Producing
7 Party.

8 3. SCOPE

9 The protections conferred by this Stipulation and Order cover not only Protected Material (as
10 defined above), but also (1) any information copied or extracted from Protected Material; (2) all copies,
11 excerpts, summaries, or compilations of Protected Material; and (3) any testimony, conversations, or
12 presentations by Parties or their Counsel that might reveal Protected Material. However, the protections
13 conferred by this Stipulation and Order do not cover the following information: (a) any information that is
14 in the public domain at the time of disclosure to a Receiving Party or becomes part of the public domain
15 after its disclosure to a Receiving Party as a result of publication not involving a violation of this Order,
16 including becoming part of the public record through trial or otherwise; and (b) any information known to
17 the Receiving Party prior to the disclosure or obtained by the Receiving Party after the disclosure from a
18 source who obtained the information lawfully and under no obligation of confidentiality to the Designating
19 Party. Any use of Protected Material at trial shall be governed by a separate agreement or order.

20 4. DURATION

21 Even after final disposition of this litigation, the confidentiality obligations imposed by this Order
22 shall remain in effect until a Designating Party agrees otherwise in writing or a court order otherwise
23 directs. Final disposition shall be deemed to be the later of (1) dismissal of all claims and defenses in this
24 action, with or without prejudice; and (2) final judgment herein after the completion and exhaustion of all
25 appeals, rehearings, remands, trials, or reviews of this action, including the time limits for filing any
26 motions or applications for extension of time pursuant to applicable law.

1 5. DESIGNATING PROTECTED MATERIAL

2 5.1 Exercise of Restraint and Care in Designating Material for Protection. Each Party or Non-
3 Party that designates information or items for protection under this Order must take care to limit any such
4 designation to specific material that qualifies under the appropriate standards. The Designating Party must
5 designate for protection only those parts of material, documents, items, or oral or written communications
6 that qualify – so that other portions of the material, documents, items, or communications for which
7 protection is not warranted are not swept unjustifiably within the ambit of this Order.

8 Mass, indiscriminate, or routinized designations are prohibited. Designations that are shown to be
9 clearly unjustified or that have been made for an improper purpose (e.g., to unnecessarily encumber or
10 retard the case development process or to impose unnecessary expenses and burdens on other parties)
11 expose the Designating Party to sanctions.

12 If it comes to a Designating Party’s attention that information or items that it designated for
13 protection do not qualify for protection, that Designating Party must promptly notify all other Parties that
14 it is withdrawing the mistaken designation.

15 5.2 Manner and Timing of Designations. Except as otherwise provided in this Order (see,
16 e.g., second paragraph of section 5.2(a) below), or as otherwise stipulated or ordered, Disclosure or
17 Discovery Material that qualifies for protection under this Order must be clearly so designated before the
18 material is disclosed or produced.

19 Designation in conformity with this Order requires:

20 (a) for information in documentary form (e.g., paper or electronic documents, but
21 excluding transcripts of depositions or other pretrial or trial proceedings), that the Producing Party affix
22 the legend “CONFIDENTIAL” to each page that contains protected material. If only a portion or portions
23 of the material on a page qualifies for protection, the Producing Party also must clearly identify the
24 protected portion(s) (e.g., by making appropriate markings in the margins).

25 A Party or Non-Party that makes original documents or materials available for inspection need not
26 designate them for protection until after the inspecting Party has indicated which material it would like
27 copied and produced. During the inspection and before the designation, all of the material made available
28 for inspection shall be deemed “CONFIDENTIAL.” After the inspecting Party has identified the

1 documents it wants copied and produced, the Producing Party must determine which documents, or
2 portions thereof, qualify for protection under this Order. Then, before producing the specified documents,
3 the Producing Party must affix the “CONFIDENTIAL” legend to each page that contains Protected
4 Material. If only a portion or portions of the material on a page qualifies for protection, the Producing
5 Party also must clearly identify the protected portion(s) (e.g., by making appropriate markings in the
6 margins).

7 (b) for testimony given in deposition or in other pretrial or trial proceedings, that the
8 Designating Party identify on the record, before the close of the deposition, hearing, or other proceeding,
9 all protected testimony.

10 (c) for information produced in some form other than documentary and for any other
11 tangible items, that the Producing Party affix in a prominent place on the exterior of the container or
12 containers in which the information or item is stored the legend “CONFIDENTIAL.” If only a portion or
13 portions of the information or item warrant protection, the Producing Party, to the extent practicable, shall
14 identify the protected portion(s).

15 5.3 Inadvertent Failures to Designate. If timely corrected, an inadvertent failure to designate
16 qualified information or items does not, standing alone, waive the Designating Party’s right to secure
17 protection under this Order for such material. Upon timely correction of a designation, the Receiving Party
18 must make reasonable efforts to assure that the material is treated in accordance with the provisions of this
19 Order.

20 6. CHALLENGING CONFIDENTIALITY DESIGNATIONS

21 6.1 Timing of Challenges. Any Party or Non-Party may challenge a designation of
22 confidentiality at any time. Unless a prompt challenge to a Designating Party’s confidentiality designation
23 is necessary to avoid foreseeable, substantial unfairness, unnecessary economic burdens, or a significant
24 disruption or delay of the litigation, a Party does not waive its right to challenge a confidentiality
25 designation by electing not to mount a challenge promptly after the original designation is disclosed.

26 6.2 Meet and Confer. The Challenging Party shall initiate the dispute resolution process by
27 providing written notice of each designation it is challenging and describing the basis for each challenge.
28 To avoid ambiguity as to whether a challenge has been made, the written notice must recite that the

1 challenge to confidentiality is being made in accordance with this specific paragraph of the Protective
2 Order. The parties shall attempt to resolve each challenge in good faith and must begin the process by
3 conferring directly (in voice to voice dialogue; other forms of communication are not sufficient) within 14
4 days of the date of service of notice. In conferring, the Challenging Party must explain the basis for its
5 belief that the confidentiality designation was not proper and must give the Designating Party an
6 opportunity to review the designated material, to reconsider the circumstances, and, if no change in
7 designation is offered, to explain the basis for the chosen designation. A Challenging Party may proceed to
8 the next stage of the challenge process only if it has engaged in this meet and confer process first or
9 establishes that the Designating Party is unwilling to participate in the meet and confer process in a timely
10 manner.

11 6.3 Judicial Intervention. If the Parties cannot resolve a challenge without court intervention,
12 the Designating Party shall file and serve a motion to retain confidentiality under Civil Local Rule 7 (and
13 in compliance with Civil Local Rule 79-5 and General Order 62, if applicable) within 21 days of the initial
14 notice of challenge or within 14 days of the parties agreeing that the meet and confer process will not
15 resolve their dispute, whichever is earlier. Each such motion must be accompanied by a competent
16 declaration affirming that the movant has complied with the meet and confer requirements imposed in the
17 preceding paragraph. Failure by the Designating Party to make such a motion including the required
18 declaration within 21 days (or 14 days, if applicable) shall automatically waive the confidentiality
19 designation for each challenged designation. In addition, the Challenging Party may file a motion
20 challenging a confidentiality designation at any time if there is good cause for doing so, including a
21 challenge to the designation of a deposition transcript or any portions thereof. Any motion brought
22 pursuant to this provision must be accompanied by a competent declaration affirming that the movant has
23 complied with the meet and confer requirements imposed by the preceding paragraph.

24 The burden of persuasion in any such challenge proceeding shall be on the Designating Party.
25 Frivolous challenges, and those made for an improper purpose (e.g., to harass or impose unnecessary
26 expenses and burdens on other parties) may expose the Challenging Party to sanctions. Unless the
27 Designating Party has waived the confidentiality designation by failing to file a motion to retain
28 confidentiality as described above, all parties shall continue to afford the material in question the level of

1 protection to which it is entitled under the Producing Party’s designation until the court rules on the
2 challenge.

3 7. ACCESS TO AND USE OF PROTECTED MATERIAL

4 7.1 Basic Principles. A Receiving Party may use Protected Material that is disclosed or
5 produced by another Party or by a Non-Party in connection with this case only for prosecuting, defending,
6 or attempting to settle this litigation. Such Protected Material may be disclosed only to the categories of
7 persons and under the conditions described in this Order. When the litigation has been terminated, a
8 Receiving Party must comply with the provisions of section 13 below (FINAL DISPOSITION).

9 Protected Material must be stored and maintained by a Receiving Party at a location and in a
10 secure manner that ensures that access is limited to the persons authorized under this Order.

11 7.2 Disclosure of “CONFIDENTIAL” Information or Items. Unless otherwise ordered by the
12 court or permitted in writing by the Designating Party, a Receiving Party may disclose any information or
13 item designated “CONFIDENTIAL” only to:

14 (a) the Receiving Party’s Outside Counsel of Record in this action, as well as employees
15 of said Outside Counsel of Record to whom it is reasonably necessary to disclose the information for this
16 litigation and who have signed the “Acknowledgment and Agreement to Be Bound” that is attached hereto
17 as Exhibit A;

18 (b) the officers, directors, and employees (including House Counsel) of the Receiving
19 Party to whom disclosure is reasonably necessary for this litigation and who have signed the
20 “Acknowledgment and Agreement to Be Bound” (Exhibit A);

21 (c) Experts (as defined in this Order) of the Receiving Party to whom disclosure is
22 reasonably necessary for this litigation and who have signed the “Acknowledgment and Agreement to Be
23 Bound” (Exhibit A);

24 (d) the court and its personnel;

25 (e) court reporters and their staff, professional jury or trial consultants, mock jurors, and
26 Professional Vendors to whom disclosure is reasonably necessary for this litigation and who have signed
27 the “Acknowledgment and Agreement to Be Bound” (Exhibit A);

28 (f) during their depositions, witnesses in the action to whom disclosure is reasonably

1 necessary and who have signed the “Acknowledgment and Agreement to Be Bound” (Exhibit A), unless
2 otherwise agreed by the Designating Party or ordered by the court. Pages of transcribed deposition
3 testimony or exhibits to depositions that reveal Protected Material must be separately bound by the court
4 reporter and may not be disclosed to anyone except as permitted under this Stipulated Protective Order.

5 (g) the author or recipient of a document containing the information or a custodian or
6 other person who otherwise possessed or knew the information.

7 8. PROTECTED MATERIAL SUBPOENAED OR ORDERED PRODUCED IN OTHER
8 LITIGATION

9 If a Party is served with a subpoena or a court order issued in other litigation that compels
10 disclosure of any information or items designated in this action as “CONFIDENTIAL,” that Party must:

11 (a) promptly notify in writing the Designating Party. Such notification shall include a
12 copy of the subpoena or court order;

13 (b) promptly notify in writing the party who caused the subpoena or order to issue in the
14 other litigation that some or all of the material covered by the subpoena or order is subject to this
15 Protective Order. Such notification shall include a copy of this Stipulated Protective Order; and

16 (c) cooperate with respect to all reasonable procedures sought to be pursued by the
17 Designating Party whose Protected Material may be affected.

18 If the Designating Party timely seeks a protective order, the Party served with the subpoena or
19 court order shall not produce any information designated in this action as “CONFIDENTIAL” before a
20 determination by the court from which the subpoena or order issued, unless the Party has obtained the
21 Designating Party’s permission. The Designating Party shall bear the burden and expense of seeking
22 protection in that court of its confidential material – and nothing in these provisions should be construed as
23 authorizing or encouraging a Receiving Party in this action to disobey a lawful directive from another
24 court.

25 9. A NON-PARTY’S PROTECTED MATERIAL SOUGHT TO BE PRODUCED IN THIS
26 LITIGATION

27 (a) The terms of this Order are applicable to information produced by a Non-Party in
28 this action and designated as “CONFIDENTIAL.” Such information produced by Non-Parties in

1 connection with this litigation is protected by the remedies and relief provided by this Order. Nothing in
2 these provisions should be construed as prohibiting a Non-Party from seeking additional protections.

3 (b) In the event that a Party is required, by a valid discovery request, to produce a
4 Non-Party's confidential information in its possession, and the Party is subject to an agreement with the
5 Non-Party not to produce the Non-Party's confidential information, then the Party shall:

6 (1) promptly notify in writing the Requesting Party and the Non-Party that
7 some or all of the information requested is subject to a confidentiality agreement with a Non-Party;

8 (2) promptly provide the Non-Party with a copy of the Stipulated Protective
9 Order in this litigation, the relevant discovery request(s), and a reasonably specific description of the
10 information requested; and

11 (3) make the information requested available for inspection by the Non-Party.

12 (c) If the Non-Party fails to object or seek a protective order from this court within 14
13 days of receiving the notice and accompanying information, the Receiving Party may produce the Non-
14 Party's confidential information responsive to the discovery request. If the Non-Party timely seeks a
15 protective order, the Receiving Party shall not produce any information in its possession or control that is
16 subject to the confidentiality agreement with the Non-Party before a determination by the court.¹ Absent a
17 court order to the contrary, the Non-Party shall bear the burden and expense of seeking protection in this
18 court of its Protected Material.

19 10. UNAUTHORIZED DISCLOSURE OF PROTECTED MATERIAL

20 If a Receiving Party learns that, by inadvertence or otherwise, it has disclosed Protected Material
21 to any person or in any circumstance not authorized under this Stipulated Protective Order, the Receiving
22 Party must immediately (a) notify in writing the Designating Party of the unauthorized disclosures, (b) use
23 its best efforts to retrieve all unauthorized copies of the Protected Material, (c) inform the person or
24 persons to whom unauthorized disclosures were made of all the terms of this Order, and (d) request such

28 rights of a Non-Party and to afford the Non-Party an opportunity to protect its confidentiality
interests in this court.

1 person or persons to execute the “Acknowledgment and Agreement to Be Bound” that is attached hereto
2 as Exhibit A.

3 11. INADVERTENT PRODUCTION OF PRIVILEGED OR OTHERWISE PROTECTED
4 MATERIAL

5 When a Producing Party gives notice to Receiving Parties that certain inadvertently produced
6 material is subject to a claim of privilege or other protection, the obligations of the Receiving Parties are
7 those set forth in Federal Rule of Civil Procedure 26(b)(5)(B). This provision is not intended to modify
8 whatever procedure may be established in an e-discovery order that provides for production without prior
9 privilege review. Pursuant to Federal Rule of Evidence 502(d) and (e), insofar as the parties reach an
10 agreement on the effect of disclosure of a communication or information covered by the attorney-client
11 privilege or work product protection, the parties may incorporate their agreement in the stipulated
12 protective order submitted to the court.

13 12. MISCELLANEOUS

14 12.1 Right to Further Relief. Nothing in this Order abridges the right of any person to seek its
15 modification by the court in the future.

16 12.2 Right to Assert Other Objections. By stipulating to the entry of this Protective Order no
17 Party waives any right it otherwise would have to object to disclosing or producing any information or
18 item on any ground not addressed in this Stipulated Protective Order. Similarly, no Party waives any right
19 to object on any ground to use in evidence of any of the material covered by this Protective Order.

20 12.3 Filing Protected Material. Without written permission from the Designating Party or a
21 court order secured after appropriate notice to all interested persons, a Party may not file in the public
22 record in this action any Protected Material. A Party that seeks to file under seal any Protected Material
23 must comply with Civil Local Rule 79-5 and General Order 62. Protected Material may only be filed
24 under seal pursuant to a court order authorizing the sealing of the specific Protected Material at issue.
25 Pursuant to Civil Local Rule 79-5 and General Order 62, a sealing order will issue only upon a request
26 establishing that the Protected Material at issue is privileged, protectable as a trade secret, or otherwise
27 entitled to protection under the law. If a Receiving Party's request to file Protected Material under seal
28 pursuant to Civil Local Rule 79-5(d) and General Order 62 is denied by the court, then the Receiving Party

1 may file the information in the public record pursuant to Civil Local Rule 79-5(e) unless otherwise
2 instructed by the court.

3 13. FINAL DISPOSITION

4 Within 60 days after the final disposition of this action, as defined in paragraph 4, each Receiving
5 Party must return all Protected Material to the Producing Party or destroy such material. As used in this
6 subdivision, "all Protected Material" includes all copies, abstracts, compilations, summaries, and any other
7 format reproducing or capturing any of the Protected Material. Whether the Protected Material is returned
8 or destroyed, the Receiving Party must submit a written certification to the Producing Party (and, if not the
9 same person or entity, to the Designating Party) by the 60 day deadline that (1) identifies (by category,
10 where appropriate) all the Protected Material that was returned or destroyed and (2) affirms that the
11 Receiving Party has not retained any copies, abstracts, compilations, summaries or any other format
12 reproducing or capturing any of the Protected Material. Notwithstanding this provision, Counsel are
13 entitled to retain an archival copy of all pleadings, motion papers, trial, deposition, and hearing transcripts,
14 legal memoranda, correspondence, deposition and trial exhibits, expert reports, attorney work product, and
15 consultant and expert work product, even if such materials contain Protected Material. Any such archival
16 copies that contain or constitute Protected Material remain subject to this Protective Order as set forth in
17 Section 4 (DURATION).

18 IT IS SO STIPULATED, THROUGH COUNSEL OF RECORD.


