3 enter an Order as follows:

4 WHEREAS on May 31, 2012, Defendant CGI filed its Notice of Motion and Motion for  
5 Summary Judgment of Invalidity, and CGI scheduled the hearing on its Motion for July 10, 2012  
6 at 9:00 a.m. (Dkt. No. 142);

7 WHEREAS the parties agree that additional time is warranted to complete the briefing for  
8 CGI's Motion for Summary Judgment due to the number of issues raised in the Motion;

9 WHEREAS CGI relies on an expert declaration of Dr. Michael Metzker in support of its  
10 Motion for Summary Judgment;

11 WHEREAS Illumina has requested to depose Dr. Metzker before filing its opposition to


