On March 21, 2013, the Court issued its Findings of Fact and Conclusions of Law in the above-captioned matters. Case No. 10-cv-05591-SC ECF No. 194; Case No. 11-cv-02861-SC ECF No. 261. In accordance with those findings, the Court now enters JUDGMENT as follows.

With respect to Case Number 10-cv-05591-SC, the Court enters JUDGMENT in favor of Defendants SeaMaster Logistics, Inc. and Summit Logistics International, Inc. on all claims asserted by Plaintiff Mitsui O.S.K. Lines. The Court also enters JUDGMENT in favor of Plaintiff Mitsui O.S.K. Lines on all counterclaims

1 asserted by Defendants SeaMaster Logistics, Inc. and Summit  
2 Logistics International, Inc.

3 As to Case Number 11-cv-02861-SC, the Court enters JUDGMENT in  
4 favor of Plaintiff Mitsui O.S.K. Lines and against Defendants  
5 SeaMaster Logistics, Inc., Summit Logistics International, Inc.,  
6 and Kesco Container Lines, Inc. on Plaintiff Mitsui O.S.K. Lines'  
7 claims for intentional misrepresentation, negligent  
8 misrepresentation, and conspiracy - intentional misrepresentation  
9 in the amount of \$9,364,466.18. Defendant SeaMaster Logistics,  
10 Inc. shall be liable for \$1,080,073.07 in damages and Defendants  
11 Summit Logistics International, Inc. and Kesco Container Lines,  
12 Inc. shall be jointly and severally liable for \$8,284,393.11 in  
13 damages. The Court enters JUDGMENT in favor of SeaMaster  
14 Logistics, Inc., Summit Logistics International, Inc., and Kesco  
15 Container Lines, Inc., as to Plaintiff Mitsui O.S.K. Lines' claims  
16 under the Racketeer Influenced and Corrupt Organizations Act. The  
17 Court enters JUDGMENT in favor of Defendant Kesco Shipping, Inc. as  
18 to all claims asserted by Plaintiff Mitsui O.S.K. Lines. Finally,  
19 the Court enters JUDGMENT in favor of Plaintiff Mitsui O.S.K. Lines  
20 as to all counterclaims asserted by Defendants.
