In the Motion, the Circuit City Trust 21 seeks reconsideration of that portion of the Order granting summary judgment as to claims for 22 damages based on purchases of LCD products from Hitachi America, Inc. as an entity owned or 23 controlled by Hitachi, Ltd. 24 25 On August 19, 2014, the Court granted Circuit City Trust leave to file the Motion under 26 Local Rule 7-9 and gave defendants until September 8, 2014 to file responsive papers. MDL Master Dkt. 9189. On September 8, 2014, defendants filed a Statement of Non-Opposition to Plaintiff Circuit City Trust's Motion for Reconsideration, in which they state they "do not oppose the relief requested in plaintiff's Motion for Reconsideration filed July 15, 2014. MDL Master Dkt. 9213 at 1.

In light of defendants' non-opposition to the Motion, and for the reasons for reconsideration stated in the Motion, the Court hereby GRANTS Circuit City Trust's Motion for Reconsideration. Therefore, Defendants' Motion for Summary Judgment Based on Undisclosed Conspirators or Affiliates is DENIED as to claims of the Circuit City Trust for damages based on purchases of LCD products from Hitachi America, Inc. as an entity owned or controlled by Hitachi, Ltd.
