On October 11, 2012, the parties filed a Stipulation to Stay Proceedings. (ECF No. 93.) On October 15, 2012, the Court granted the stipulation and ordered: "All proceedings in this case . . . shall be stayed pending the completion of the parties' attempts to achieve a resolution outside this matter. The parties shall file a joint status report updating the Court on their settlement attempts on November 15, 2012, and every 30 days thereafter[.]" (ECF No. 94 at 2.) Pursuant to that order, the parties submit this Joint Status Report updating the Court on their settlement attempts.

## **Status Update**

Since October 15, the Government Defendants have made a proposal to Plaintiff Michael Almy that would resolve this matter without further litigation. Mr. Almy has considered the proposal and has responded with a counter-proposal. The parties will continue these discussions and their efforts to resolve this case without the Court's involvement.
