 SECOND STIPULATION TO EXTEND DEADLINE
 TO RESPOND TO COMPLAINT

1 Pursuant to Civil Local Rule 6-1(a), Plaintiffs John Stalcup, Dennis McGowan, and Michael
2 Lyster, and defendants University of Northern California Foundation ("UNCF") and Y. King Liu
3 (Chairman of the Board, University of Northern California Foundation) hereby stipulate and agree to
4 extend the deadline for each defendant to respond to plaintiffs' complaint.

5 On January 3, 2011, defendants removed this action to this Court from the Superior Court of
6 the State of California in and for the County of Sonoma. On January 6, 2011, the parties filed a
7 stipulation that UNCF and Y. King Liu would have until January 24, 2011 to respond to the complaint.
8 On January 20, 2011, the parties have stipulated to further extend the deadline for UNCF and Y. King
9 Liu to respond to the complaint to March 15, 2011.

11 Additionally, the parties have agreed to the following deadlines:


12 Last day for plaintiffs to file a motion for remand is February 18, 2011;

13 Hearing date to be noticed on a motion for remand is March 25, 2011;

14 Hearing date to be noticed on a motion to dismiss is March 25, 2011.

15 Such extension is intended to facilitate the parties' settlement discussions, in an effort to
16 resolve this case in an efficient manner.
