 ) **ENTIRE ACTION; [PROPOSED] ORDER**

19 IT IS HEREBY STIPULATED by and between Plaintiff Janice Evans (“Plaintiff”) and  
 20 Defendant Huong T. Le dba Pete’s Stop aka Pete’s Stop & Mini Mart (“Defendant”), by and  
 21 through their respective counsel, that pursuant to Federal Rule of Civil Procedure 41(a)(2),  
 22 Defendant Huong T. Le dba Pete’s Stop aka Pete’s Stop & Mini Mart be dismissed with  
 23 prejudice from this action.

24 IT IS FURTHER STIPULATED between Plaintiff and Defendant that this case has been  
 25 settled as between them and all issues and controversies have been resolved to their mutual  
 26 satisfaction. Plaintiff and Defendant request the Court to retain jurisdiction to enforce the terms  
 27 of their settlement agreement under the authority of *Kokkonen v. Guardian Life Ins. Co. of*
