could and would testify competently thereto. 1 2. 2 On January 11, 2011, SCEA filed an Administrative Motion to File Under Seal 3 Exhibits D, G, U, V, W, Y, and CC to the Bricker Declaration. However, Exhibits T and X to the Bricker Declaration were inadvertently omitted from that filing. 4 5 3. Like Exhibits D, G, U, V, W, Y and CC, Exhibits T and X contain explicit instructions on how to circumvent the technological protection measures ("TPMs") in SCEA's 6 7 PlayStation®3 computer entertainment system ("PS3 System"). 8 4. SCEA has brought this action to put an end to Defendants' illegal circumvention 9 of these TPMs in its PS3 System. SCEA, therefore, does not want the means of such 10 circumvention – the very practice it is aiming to stop – to be a matter of public record, thereby 11 making the information further available and enabling others to engage in this illegal practice. 5. SCEA's request is narrowly tailored to seal only those materials for which good 12 13 cause to seal has been established.
