15 Plaintiff TIMOTHY ELDER and Defendant NATIONAL CONFERENCE OF BAR  
16 EXAMINERS ("NCBE") (hereafter "the parties"), pursuant to Local Rules 7-7, 7-12 and 16-10,  
17 jointly request that the Court continue the following, for the reasons set forth below: (1) the Case  
18 Management Conference currently set for July 12, 2011 at 2:30 p.m.; (2) the hearing on  
19 Defendant NCBE's Motion to Dismiss currently set for July 8, 2011 at 9:00 a.m.; and (3) the  
20 hearing on Plaintiff Timothy Elder's Motion for Reasonable Attorneys' Fees and Costs ("Motion  
21 for Attorneys' Fees) currently set for July 8, 2011 at 9:00 a.m. The parties jointly request that the
