18 On January 25, 2011, United States Customs and Border Protection (“CBP”) issued a Notice
 19 to Appear (“NTA”) charging Petitioner Selenge Sainbuyan with inadmissibility. CBP served the
 20 NTA on Sainbuyan when she appeared for deferred inspection on January 25, 2011, and CBP will
 21 file the NTA with the immigration court. By doing so, CBP will commence removal proceedings
 22 against Sainbuyan before an immigration judge under 8 U.S.C. § 1229a. *See* 8 C.F.R. §§ 1003.14(a),
 23 1239.1(a). The parties have also addressed the legal status of Sainbuyan’s minor son, under relevant
 24 United States immigration law, in a mutually agreeable fashion.

25 Accordingly the parties agree that this case is moot, and the parties stipulate to dismissal of
 26 the case with prejudice pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii). The parties
 27 agree to bear their own fees and costs.
