1 I, Carolyn J. Wilder, hereby declare as follows:

2 1. The following facts are of my own personal knowledge, and if called as a witness
3 I could and would testify competently as to their truth.


4 2. I am currently an elected Assistant Secretary of AT&T Mobility Corporation, the
5 Manager of AT&T Mobility LLC ("ATTM"). In my position as a Senior Corporate Paralegal, I
6 maintain the corporate records and minute books for ATTM and its subsidiaries.

7 3. Before January 2007, ATTM was known as Cingular Wireless LLC ("Cingular").

8 4. Cingular began operating in October 2000 as a joint venture between SBC
9 Communications, Inc. and BellSouth Corporation. AT&T Corporation was not a part of the joint
10 venture and had no other corporate relationship with Cingular.

11 5. In November 2005, SBC Communications, Inc. completed its merger with AT&T
12 Corporation, and on November 18, 2005 SBC Communications, Inc. changed its name to AT&T
13 Inc. In December 2006, AT&T Inc. completed its acquisition of BellSouth Corporation, thereby
14 consolidating ownership of Cingular. Cingular's name was changed to AT&T Mobility LLC on
15 January 8, 2007.

16 I declare under penalty of perjury that the foregoing is true and correct. Executed on
