**ORDER OF PARTIAL DISMISSAL  
AND OF TRANSFER**

**INTRODUCTION**

Plaintiff, a California prisoner proceeding pro se, filed this civil rights action pursuant to 42 U.S.C. 1983. He has applied for leave to proceed in forma pauperis.

**ANALYSIS**

**A. STANDARD OF REVIEW**

Federal courts must engage in a preliminary screening of cases in which prisoners seek redress from a governmental entity or officer or employee of a governmental entity. 28 U.S.C. § 1915A(a). In its review the court must identify any cognizable claims, and dismiss any claims which are frivolous, malicious, fail to state a claim upon which relief may be granted, or seek monetary relief from a defendant who is immune from such relief. *Id.* at 1915A(b)(1),(2). Pro se pleadings must be liberally construed. *Balistreri v. Pacifica Police Dep't*, 901 F.2d 696, 699 (9th Cir. 1990).

1 Federal Rule of Civil Procedure 8(a)(2) requires only "a short and plain statement of the  
2 claim showing that the pleader is entitled to relief." "Specific facts are not necessary; the  
3 statement need only "give the defendant fair notice of what the . . . claim is and the grounds  
4 upon which it rests." *Erickson v. Pardus*, 127 S. Ct. 2197, 2200 (2007) (citations omitted).  
5 Although in order to state a claim a complaint "does not need detailed factual allegations, . . . a  
6 plaintiff's obligation to provide the 'grounds of his 'entitle[ment] to relief' requires more than  
7 labels and conclusions, and a formulaic recitation of the elements of a cause of action will not  
8 do. . . . Factual allegations must be enough to raise a right to relief above the speculative  
9 level." *Bell Atlantic Corp. v. Twombly*, 127 S. Ct. 1955, 1964-65 (2007) (citations omitted). A  
10 complaint must proffer "enough facts to state a claim for relief that is plausible on its face." *Id.*  
11 at 1974.

12 To state a claim under 42 U.S.C. § 1983, a plaintiff must allege two essential elements:  
13 (1) that a right secured by the Constitution or laws of the United States was violated, and (2)  
14 that the alleged deprivation was committed by a person acting under the color of state law.  
15 *West v. Atkins*, 487 U.S. 42, 48 (1988).

16 **B. LEGAL CLAIMS**

17 Plaintiff alleges that he was injured in an attack from other inmates in 1999 at Salinas  
18 Valley State Prison ("SVSP"), in Soledad, California. In 2003, plaintiff was transferred to  
19 Pleasant Valley State Prison ("PVSP"), in Coalinga, California. He alleges that following his  
20 attack, he received inadequate medical care first at SVSP and, after being transferred, at PVSP.  
21 He alleges that Dr. Lee, Dr. Bowhan, Dr. Wong and Dr. Lustman provided him with inadequate  
22 medical care at SVSP and at the nearby contracted medical clinic called the Natividad Medical  
23 Center. He alleges that Dr. Duenas, Dr. Reshid, Captain Williams and Correctional Officer  
24 Cantu were responsible for his inadequate medical care at PVSP and at the nearby contracted  
25 hospital, Mercy Hospital.

26 The claims against the defendants Lee, Bowhan, Wong, and Lustman, which are based  
27 on their conduct prior to 2003, when plaintiff was transferred from SVSP to PVSP, are time-  
28 barred. Section 1983 does not contain its own limitations period, but the appropriate period is

1 that of the forum state's statute of limitations for personal injury torts, which, in California is the  
2 two-year period set forth at California Civil Procedure Code § 335.1. *Maldonado v. Harris*,  
3 370 F.3d 945, 954 (9th Cir. 2004). Plaintiff's claims accrued prior to 2003, which is when he  
4 alleges that he received the medical care, or lack thereof, from the defendants at SVSP and  
5 Natividad Medical Center. *See Zolotarev v. San Francisco*, 535 F.3d 1044, 1049 (9th Cir.  
6 2008) (under federal law, a claim generally accrues when the plaintiff knows or has reason to  
7 know of the injury which is the basis of the action). Plaintiff knew of the medical treatment  
8 these defendants were choosing to give him and not to give him, when it occurred. That  
9 plaintiff might not have learned of the legal significance of the medical treatment the defendants  
10 were providing and not providing until later does not delay the accrual of the cause of action  
11 arising out of those decisions. *See ibid.* And although the limitation period may have been  
12 tolled due to plaintiff's imprisonment, such tolling is available only for a maximum of two  
13 years. *See Cal. Civ. Proc. Code § 352.1(a)*. Thus, plaintiff had a maximum of four years in  
14 which to bring his claim under Section 1983, i.e., the regular two-year period under California  
15 Civil Procedure Code Section 335.1 plus two years of tolling due to his imprisonment. As it is  
16 clear from the allegations in the complaint that plaintiff waited over eight years after 2003  
17 before filing the complaint herein, the claims against defendants Lustman, Wong, Lee and  
18 Bowhan must be dismissed as untimely.

19 Plaintiff's remaining claims are based on the medical care he received at PVSP and at  
20 Mercy Hospital. PVSP is in Fresno County, and Mercy Hospital is in Bakersfield, and as such  
21 they both lie within the venue of the United States District Court for the Eastern District of  
22 California. Venue is preferable in the Eastern District because that is where the acts  
23 complained of against the remaining defendants are alleged to have occurred, and also where  
24 the remaining defendants are located. *See 28 U.S.C. 1391, 1404*. Accordingly, in the interests  
25 of justice, this case will be transferred for resolution of the remaining claims to the United  
26 States District Court for the Eastern District of California. *See 28 U.S.C. 1404(a)*.

27 **CONCLUSION**

28 For the reasons set out above, the claims against defendants Lustman, Wong, Lee and

1 Bowhan are **DISMISSED**. This case is **TRANSFERRED** to the United States District Court for the  
2 Eastern District of California for adjudication of the remaining claims herein, against  
3 defendants Duenas, Reshid, Williams and Cantu. *See* 28 U.S.C. 1404(a). Ruling on plaintiff's  
4 IFP application will be deferred to the Eastern District.

5 The clerk shall transfer this matter forthwith and terminate docket number 2 from the  
6 docket in this court.

7 **IT IS SO ORDERED.**
