13 Plaintiff's application for a preliminary injunction is set for hearing on October 12, 2011. On
14 October 2, 2011, the day before his opposition papers were due, defendant Castle filed an ex parte
15 application seeking to continue the hearing and change the briefing schedule. His need for additional
16 time was caused by the unforeseen length of an unrelated trial. Doc. 67.

17 Defendant's request is hereby GRANTED. The October 12, 2011 hearing is VACATED, and
18 is reset for **November 4, 2011 at 9 A.M.** Defendant's opposition to the preliminary injunction
19 application is due by **October 10, 2011**, and plaintiff's reply is due by **October 17, 2011**. The
20 temporary restraining order issued September 6, 2011 remains in place until further order of court..
