24 TO ALL PARTIES AND THEIR COUNSEL OF RECORD:

25 The Court having considered the stipulation of NORDEA BANK FINLAND
 26 PLC, SINGAPORE BRANCH and MARIANNE KIRK A.S., as well as its file herein, and
 27 for good cause showing, HEREBY ORDERS THAT:

1 1. MARIANNE KIRK A.S. ("Kirk") is entitled to recover USD\$40,665.80
2 in valid *custodia legis* expenses.

3 2. The Clerk of the Court shall issue a check sourced from the funds on
4 deposit with the Registry of the Court from the proceeds of sale of the Singapore flagged
5 tanker M/T/ *BLUE JADE*, IMO No. 9419735, her masts, boilers, cables, engines,
6 machinery, etc. (the "Vessel") in the amount of USD\$40,665.80 made payable to
7 KEESAL, YOUNG & LOGAN, such payment constituting full satisfaction of any of
8 claims by Kirk against the Vessel and/or proceeds of sale.

9 3. R.S. PLATOU SHIPBROKERS A.S ("Platou") is entitled to recover
10 USD\$176,275 in valid *custodia legis* expenses.

11 4. The Clerk of the Court shall issue a check sourced from the funds on
12 deposit with the Registry of the Court from the proceeds of sale of the Vessel in the
13 amount of USD\$176,275 made payable to KEESAL, YOUNG & LOGAN, such payment
14 constituting full satisfaction of Platou's *custodia legis* expenses.

15 5. The Clerk of the Court shall issue a check for the entire remaining
16 balance of the funds on deposit with the Registry of the Court from the proceeds of sale
17 of the Vessel, inclusive of all accrued interest, to NORDEA BANK FINLAND PLC,
18 SINGAPORE BRANCH made payable to KEESAL, YOUNG & LOGAN consistent with
19 the default judgment in action *in rem* entered in favor of Nordea on July 22, 2011.
