1 The motion by Plaintiffs, which seeks an award of attorneys' fees, costs and incentive awards,
2 came on for hearing before this Court on June 28, 2013. The Court, having considered all papers and
3 arguments made with respect to the Motion for Award of Attorneys' Fees, Costs and Incentive Awards,
4 hereby finds and orders as follows:

5 **FINDINGS:**

6 1. An award of Four Hundred Ninety Thousand Dollars and No Cents (\$490,000) in
7 attorneys' fees and costs to Class Counsel is fair and reasonable in light of the nature of this case, Class
8 Counsel's experience and efforts in prosecuting this action, and the benefits obtained for the Settlement
9 Class members.


10 2. An incentive award to each Class Representative, Jason Salmonson, Jessica Shughrou,
11 Carlos Campbell, Nancy Dardarian, Thomas O'Connor, Tiffany Heon, and Zetha Noble, in the amount of
12 Three Thousand Dollars and No Cents (\$3,000.00) is fair and reasonable in light of their risks in
13 commencing these actions as the Class representatives and the time and effort spent litigating this action
14 as the Class representatives.

15 **IT IS SO ORDERED THAT:**

16 3. **Attorneys' Fees and Costs.** Class Counsel is awarded attorneys' fees and costs in the
17 amount of \$490,000.00.

18 4. **Incentive Awards.** Class Representatives Jason Salmonson, Jessica Shughrou, Carlos
19 Campbell, Nancy Dardarian, Thomas O'Connor, Tiffany Heon, and Zetha Noble are awarded \$3,000.00
20 each as incentive awards.
