1 WHEREAS, the above-captioned action is alleged to be a class action asserting violations of  
2 the federal securities laws against defendants Equinix, Inc., Stephen M. Smith, and Keith D. Taylor  
3 (collectively, “defendants”);

4 WHEREAS, the above-captioned action is subject to the requirements of the Private  
5 Securities Litigation Reform Act of 1995, which sets forth specialized procedures for the  
6 administration of securities class actions;

7 WHEREAS, the Court appointed International Brotherhood of Electrical Workers Local 697  
8 Pension Fund as lead plaintiff and approved lead plaintiff’s choice of counsel on August 8, 2011  
9 (Dkt. No. 23);

10 WHEREAS, the parties to this action previously stipulated, pursuant to Civil L.R. 6-1(a), to  
11 allow each defendant to answer, move or otherwise respond to the lead plaintiff’s amended  
12 complaint within 45 days of the date it was filed;

13 WHEREAS, the Court approved that stipulation on August 30, 2011 (Dkt. No. 25);

14 WHEREAS, lead plaintiff filed an amended complaint on September 22, 2011 (Dkt. No. 26);

15 WHEREAS, defendants intend to file a motion to dismiss the claims asserted against them by  
16 November 7, 2011;

17 IT IS ACCORDINGLY STIPULATED, pursuant to Civil L.R. 6-1(a), by and between the  
18 undersigned counsel for the parties, that (1) defendants shall file their motion to dismiss by  
19 November 7, 2011; (2) lead plaintiff shall file its opposition to the motion to dismiss by December  
20 22, 2011; (3) defendants shall file their reply papers by January 30, 2012; and (4) the motion to  
21 dismiss shall be set for hearing on February 24, 2012 at 10:00 a.m.
