18 Petitioner has filed a pro se Petition for a Writ of  
19 Habeas Corpus under 28 U.S.C. § 2254 challenging a judgment of  
20 conviction from Sonoma County Superior Court. Doc. #1. Petitioner  
21 failed to sign this instant Petition as required by Rule 2 of the  
22 Rules Governing Section 2254 Cases and by 28 U.S.C. § 2242.

23 On February 1, 2012, the Court issued an order directing  
24 Respondent to show cause with a writ of habeas corpus should not be  
25 granted. Doc. #6. In this order, the Court also directed  
26 Petitioner to file a signed signature page for his Petition by  
27 February 24, 2012. A copy of the order was mailed to Petitioner's  
28 address of record: CSP-Solano, P.O. Box 4000, Vacaville CA 95696.

1 Another copy of the order was mailed to the return address listed on  
2 Petitioner's last communication with the Court: 954 Baxter Avenue,  
3 Sonoma CA 95476. Both orders were returned as undeliverable. See  
4 Doc. ## 7 and 8. It appears that California State Prison - Solano  
5 forwarded the order to the Santa Rosa Parole Units 1, 2, and the  
6 order was returned by the Santa Rosa Parole Unit as "Unable to  
7 Forward." Doc. #8.

8 Over five months have passed since the Court-ordered  
9 deadline for filing the signature page, and Petitioner still has not  
10 complied with the Court's order.<sup>1</sup>

11 The Court is without jurisdiction to consider the instant  
12 Petition because it was not signed and verified by Petitioner as  
13 required by Rule 2 of the Rules Governing Section 2254 Cases and by  
14 28 U.S.C. § 2242. Accordingly, this Petition is DISMISSED. The  
15 Clerk is directed to terminate any pending motions as moot and close  
16 the file.

17 IT IS SO ORDERED.
