20 **STIPULATION**

 22 1. WHEREAS, the Court ordered the parties to complete ADR before the upcoming  
 23 Further Case Management Conference on January 20, 2012;

24 2. WHEREAS, a Settlement Conference before Magistrate Judge Donna M. Ryu  
 25 was set for January 13, 2012, and the parties have timely submitted their Settlement Conference  
 26 documents for the January 13, 2012 Settlement Conference;

27 3. WHEREAS, Plaintiff was prepared to appear at the January 13, 2012 Settlement  
 28 Conference;

1           4.       WHEREAS, Plaintiff was arrested on unrelated bench warrants on January 9,  
2 2012 in Sonoma County;

11 Conference currently set for January 20, 2012, be continued an additional 60 days, to allow the  
12 parties to complete ADR by the time of the Further Case Management Conference.
