 22 WHEREAS, this is a putative wage hour class and collective action alleging that
 23 Defendants violated the Fair Labor Standards Act, 29 U.S.C., Section 200 et seq., by failing to pay
 24 Plaintiffs overtime, with related state law claims for alleged overtime, travel time pay, failure to
 25 provide meal and/or rest breaks, failure to pay prevailing wages on state public works jobs, and other
 26 wage/hour claims; and

1 WHEREAS, Defendant Incom Mechanical, Inc. is a small plumbing contractor
2 located in Petaluma, California; and

3 WHEREAS, the parties have scheduled a mediation with attorney Mark Rudy for
4 July 5, 2011; and

5
6 WHEREAS, Defendant has provided Plaintiff with relevant payroll records for all
7 putative class members, timesheets for the Plaintiffs, GPS records, and documents concerning its
8 financial condition; and

9 WHEREAS, the parties will continue to exchange relevant documents which will
10 enable Plaintiffs' counsel to prepare for the July 5 mediation, and to assess the potential settlement
11 value of the case; and

12
13 WHEREAS, the parties wish to conserve their resources, and those of the Court, in
14 the hopes that the parties will be able to reach settlement at the mediation on July 5, or thereafter;
15 and

16 WHEREAS, the parties' Rule 26(f) report and Rule 26(a) initial disclosures are
17 currently due July 28, 2011.

19 THEREFORE, the parties respectfully request that the Case Management Conference
20 currently scheduled for August 5, 2011 at 2:30 p.m. before the Hon. Susan Illston be continued
21 approximately 45 days to allow the parties to focus on attempting to settle the case, and to allow
22 sufficient time to prepare the proposed class settlement papers, if a settlement is reached, with the
23 dates for the parties' Rule 26(f) report and Rule 26(a) initial disclosures also continued for
24 approximately 45 days.
