**JOINT STIPULATED REQUEST TO  
 ENLARGE TIME TO COMPLETE  
 EARLY NEUTRAL EVALUATION AND  
 TO CONTINUE STATUS CONFERENCE;  
 [PROPOSED] ORDER THEREON**

1 Pursuant to Civil Local Rule 6-2, Plaintiff PETER TURNER (hereinafter "Plaintiff"), and  
2 Defendant CITY AND COUNTY OF SAN FRANCISCO (hereinafter "Defendant"), hereby  
3 stipulate to an enlargement of time to complete the Early Neutral Evaluation ("ENE"), and to  
4 continue the Further Status Conference, currently set for December 2, 2011.

5 WHEREAS, at a Case Management Conference held on July 15, 2011, the Court  
6 scheduled the ENE to be completed by November 15, 2011;

7 WHEREAS, the parties scheduled the ENE for November 9, 2011;

8 WHEREAS, a Further Status Conference has been set for December 2, 2011;

9 WHEREAS, Plaintiff's counsel has a case that on October 24, 2011, was set for trial  
10 commencing on the date October 27, 2011. On October 27, 2011 the trial date was continued until  
11 November 7, 2011;

12 WHEREAS, the case set for trial is an unlawful detainer, subject to expedited scheduling;

13 WHEREAS, Defendant's counsel has a deposition scheduled in New Hampshire on  
14 December 2, 2011;

15 WHEREAS, this is the first request for continuance in this matter; and,

16 WHEREAS, the granting of this continuance is not expected to materially affect any  
17 other dates set forth in the Court's July 18, 2011 Case Management and Pretrial Order for Jury  
18 Trial.

19 NOW, THEREFORE, THE PARTIES HEREBY STIPULATE AND JOINTLY  
20 REQUEST, by and through their respective counsel of record, as follows:

21 That the time to complete the ENE, currently ordered to be completed by November 15,  
22 2011, is enlarged to December 15, 2011, that the parties endeavor to complete the ENE by  
23 December 9, and that the Further Status Conference, currently set for December 2, 2011, be  
24 continued until such later date as may please the Court;

IT IS SO ORDERED.

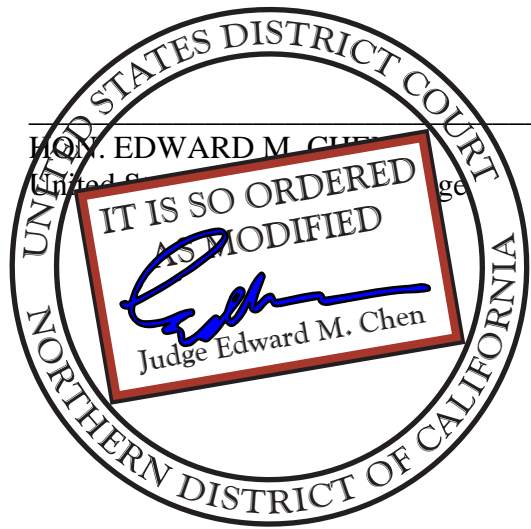
