18 The undersigned parties, through their counsel of record, have initially met and

 21 in this case. Counsel for plaintiff has corresponded with Ms. Henkel and has
 22 communicated on the telephone with an attorney representing Ms. Henkel, but this

 24 this case on her behalf, and plaintiff’s counsel would prefer to give Ms. Henkel an

 27 of settlement and believe it may be fruitful for them to have a brief additional opportunity

2 management conference.

3 The undersigned parties stipulate to and respectfully request a brief additional
4 opportunity to confer with one another and with Ms. Henkel and/or her counsel to
5 determine if she will make an appearance before the case management conference, and
6 they believe that good cause exists to grant a brief continuance of the initial case
7 management conference, now set for Wednesday, July 13 at 1:30 in this court, until
8 Wednesday, August 3, 2011 at 1:30 p.m.
