3	4. A Case Management Conference is set for July <del>13</del> , 2011. Counsel for Petitioner are located in
4	San Diego, California and Washington, DC. Lead counsel for Respondents is located in Dallas,
5	Texas. All counsel will benefit from hearing Respondents' Motion at the same time as the Court
6	conducts the Case Management Conference.
7	5. There have been no prior time modifications, either by stipulation or by Order.
8	6. Granting of the parties' request would have no effect on the existing schedule, except that
9	Petitioner's reply to Respondent's Motion would fall due on June 22, 2011, pursuant to Local
