1 I, Peter Rukin, hereby declare that:

I am a member in good standing of the State Bar of California, a partner at Rukin
 Hyland Doria & Tindall LLP, and co-counsel for Plaintiffs. I make this declaration of personal
 knowledge and if called as a witness I could and would testify competently to the facts stated
 herein.

- 6 2. This Declaration is submitted in support of Plaintiffs' Motion for Preliminary
  7 Approval of Class and Collective Action Settlement.
- 8 **Background and Experience**

3. The following is a brief description of my professional background. I am a 1991 9 graduate of New York University School of Law. Following graduation from law school, I 10 served as law clerk to U.S. District Court Judge Harry D. Leinenweber in Chicago. Thereafter, I 11 practiced law at employment law firms in Chicago (Stowell & Friedman) and New York 12 (Vladeck Waldman Elias & Engelhard), representing employees in individual and class action 13 cases, and served as an Assistant Corporation Counsel for the City of Chicago Law Department. 14 15 I also served as Of Counsel in the Employment Law Department at Paul, Hastings, Janofsky & Walker in San Francisco, where from January 2000 until March 2003, I represented employers in 16 a wide array of complex employment matters. Since forming my own firm in April 2003, I have 17 represented employees in individual, class action, and collective action lawsuits. 18

4. Since 2003, my firm has been appointed class counsel in the following cases: 19 Pryor v. I have written and spoken on employment law and litigation, and have closely 20 followed legal developments in the area. I am co-author of two chapters in the CEB practice 21 manual California Wage and Hour Law and Litigation, and have served as Revisions Editor for 22 the wage and hour chapters of the Matthew Bender treatise *California Employment Law*. I am 23 currently an advisor to the State Bar of California Labor and Employment Section Executive 24 Committee (having served a three year term from 2008-2011), and am a member of the Bar 25 Association of San Francisco Labor and Employment Section Executive Committee. 26

### **This Litigation**

27 28

I have been the attorney at my firm primarily responsible for the litigation of this

1 action since its inception. Our firm and our co-counsel, Shapiro Haber & Urmy LLP and 2 Gallenberg PC, spent months investigating this case before filing the action. That pre-filing 3 investigation included discussions with numerous Account Executives and a review of the 4 representative Plaintiffs' documents and records. After filing the case, we began discussions with 5 Yelp's counsel regarding the issues in the case, including the possible mediation of the action. 6 We requested and received a production of relevant documents and data, including documents 7 reflecting Yelp's compensation policies regarding Account Executives, employment agreements, 8 and workweek data. Additionally, Yelp produced an analysis reflecting time worked by a 9 representative sample of Account Executives, using data gathered from systems used by Account 10 Executives. 11 7. On May 11, 2011, the parties executed an agreement to toll the FLSA statute of 12 limitations effective May 11, 2011 for all absence collective action members. 13 8. On September 15, 2011, the parties engaged in a full day mediation session with 14 the Mark Rudy of Rudy, Exelrod, Zieff & Lowe. Although the parties did not reach a settlement 15 at the mediation, negotiations continued for several months. Those negotiations ultimately 16 resulted in the Settlement Agreement attached as Exhibit 1 to this declaration. 17 9. Having explored and considered the evidence in the case and the parties' 18 respective arguments regarding liability, I believe that this Settlement is fair, adequate, and 19 reasonable given the risks of continued litigation and the benefits that the Settlement provides 20 Class Members. If Plaintiffs were to prevail at class certification and trial, and were to establish 21 that Class Members worked an average of five hours of overtime per week, Plaintiffs' counsel's 22 valuation, based on workweek and salary information provided by Defendants, is that the total 23 unpaid overtime owed to Class Members during the class period would be approximately 24 \$3,480,000, with damages to the California Class of approximately \$2,850,000 and to the 25 National Class of approximately \$630,000 Based on these calculations and assumptions, the 26 Maximum Settlement Amount that will be distributed to Class Members (exclusive of fees and 27 costs, enhancement award and payment of the PAGA penalty) represents twenty five percent of 28

the potential actual damages recovery. The maximum number of workweeks worked by California Class Members during the liability period is 248. The maximum number of workweeks worked by a National Class Member is 185.

10. In support of its contention that Class Members worked little or no overtime hours, Yelp provided Plaintiffs' Counsel with data, which Yelp contends reflects that Class Members worked between 12 minutes and 2 hours and 20 minutes overtime per workweek.

11. Based on my conversations with Class Members, I believe this Settlement affords relief to Class Members who likely would never have filed individual claims for unpaid overtime wages.

12. I have litigated many wage and hour class and collective actions and have enhancement award approval as high as \$35,000. In my opinion, the proposed enhancement payments of \$5,000 for the named Plaintiffs are reasonable. The named Plaintiffs have assisted in the investigation, prosecution, and mediation of the action and accepted the risk of an adverse result. Each Plaintiff will, pursuant to the proposed settlement, provide Yelp with a full release of all known and unknown claims that he may have. Because Plaintiffs acknowledged that the settlement provided a substantial benefit to the class members to whom they owed a fiduciary duty, they agreed to these terms. Further, each Plaintiff has incurred the risk that he will experience retaliation for having participated in this litigation.

13. Simpluris, Inc. is a well-known and established claims administrator. Plaintiffs' counsel have used Simpluris to administer the claims process in other cases, and based on my experience the appointment of Simpluris for the fee it has agreed to charge in this case is fair, adequate and reasonable.

14. Plaintiffs' counsel have incurred significant attorney time to date, including to investigate the case, and expect to incur substantial additional time and expenses in connection the administration of the settlement and final approval process.

IT IS HEREBY STIPULATED AND AGREED by and between JUSTIN
 LARKIN, ANTHONY TIJERINO, and AHMAD DEANES (as Class Representatives), on behalf
 of themselves and the proposed Class of similarly situated individuals, on the one hand, and
 YELP! INC. (herein "Yelp"), on the other hand, (collectively, the "Settling Parties") as set forth
 below:

I.

### The Conditional Nature of This Stipulation.

This Stipulation Re: Settlement of Class and Collective Actions and all associated 7 exhibits or attachments (herein "Stipulation") is made for the sole purpose of attempting to 8 consummate settlement of these actions on a class and collective action basis. This Stipulation 9 and the settlement it evidences is made in compromise of disputed claims. Because this 10 Stipulation purports to settle this action on a class and collective action basis, this settlement must 11 receive preliminary and final approval from the Court. Accordingly, the Settling Parties enter 12 into this Stipulation and associated settlement on a conditional basis. In the event that the Court 13 does not execute and file the Order Granting Final Approval of Settlement, or in the event that the 14 associated Judgment does not become Final for any reason, this Stipulation shall be deemed null 15 and void *ab initio*, it shall be of no force or effect whatsoever, it shall not be referred to or utilized 16 for any purpose whatsoever, and the negotiation, terms, and entry of the Stipulation shall remain 17 subject to the provisions of Federal Rule of Evidence 408 and California Evidence Code Sections 18 19 1119 and 1152.

Yelp denies all of the allegations and claims, including as to liability, damages, 20 penalties, interest, fees, restitution and all other forms of relief as well as the class and collective 21 action allegations asserted in the Litigation. Yelp has agreed to resolve this Litigation via this 22 Stipulation, but to the extent this Stipulation is disapproved by the Court, deemed void, or does 23 not otherwise take effect, Yelp does not waive, but rather expressly reserves, all rights to 24 challenge all such claims and allegations in the Litigation upon all procedural and factual 25 grounds, including without limitation the ability to challenge class and/or collective action 26 treatment on any grounds or assert any and all defenses or privileges. The Class Representatives 27 and Class Counsel agree that Yelp retains and reserves these rights, and agree not to take 28

positions to the contrary; specifically, the Class Representatives and Class Counsel agree not to argue or present any argument, and hereby waive any argument, that this Stipulation precludes Yelp contesting class or collective action certification on any grounds if this Litigation were to proceed.

### The Parties to this Stipulation.

This Stipulation (with the associated exhibits) is made and entered into by and 6 7 among the following Settling Parties: (i) Class Representatives Justin Larkin, Anthony Tijerino, and Ahmad Deanes (on behalf of themselves and each of the California Class Members and 8 National Class Members), with the assistance and approval of Class Counsel; and (ii) Yelp, with 9 the assistance of its counsel of record in the Litigation. This Stipulation is intended by the 10 Settling Parties to fully, finally and forever resolve, discharge and settle the California Released 11 Claims and National Released Claims upon and subject to the terms and conditions hereof. This 12 Stipulation is also intended to result in the dismissal with prejudice of the underlying Litigation. 13 This Stipulation is intended to and will also result in the execution of general releases of all 14 15 claims of any nature held by the Class Representatives.

16

### III. The Litigation.

On March 29, 2011, Class Representative Justin Larkin filed this Litigation as a 17 putative Rule 23 class action on behalf of himself and others allegedly similarly situated in 18 California and a putative national collective action under the federal Fair Labor Standards Act 19 20 ("FLSA") on behalf of those allegedly similarly situated throughout the nation. Larkin alleged 21 that Yelp had violated certain state and federal employment laws, including without limitation the FLSA, the California Labor Code, the California Industrial Welfare Commission Wage Orders, 22 and the California Business and Professions Code, by purportedly, inter alia, (a) misclassifying 23 putative class members as "exempt" employees, *i.e.*, employees who are exempt under federal 24 25 and/or California law from premium overtime requirements and the other wage and hour requirements imposed on employees who do not qualify for the outside or inside salesperson 26 27 exemptions, or the executive, administrative, or professional exemptions under federal and/or state law; (b) failing to pay overtime wages; (c) failing to keep accurate and complete records of 28

putative class members' hours and wages; and (d) failing to make timely payment of wages.

On April 14, 2011, Larkin filed a First Amended Class and Collective Action
Complaint adding Anthony Tijerino and Ahmad Deanes as additional named plaintiffs. On May
23, 2011, Larkin, Tijerino, and Deanes filed a Second Amended Class and Collective Action
Complaint adding a claim for penalties under the California Labor Code's Private Attorneys
General Act, Labor Code § 2698 *et seq.*.

Following the filing of the Second Amended Class and Collective Action
Complaint and the exchange of significant amounts of information, counsel for Yelp and Class
Counsel, who are experienced in these types of cases, began a series of arms-length negotiations
which led to the scheduling of a mediation session with professional mediator Mark Rudy, Esq.
On September 15, 2011, the Settling Parties held an all-day mediation session with Mr. Rudy and,
after continued negotiations through Mr. Rudy the following week, reached the conditional
agreement reflected herein.

This Stipulation is intended to result in the creation of: (1) a Rule 23 class 14 comprised of all Persons who were employed by Yelp as an Account Executive (including 15 without limitation positions with the titles Account Executive, Account Executive Trainee, 16 Associate Account Executive Trainee, Associate Account Executive, Junior Account Executive, 17 Sales Associate, Sales Representative, and Senior Account Executive) in California from March 18 29, 2007 through the date of preliminary approval (California Class Period); and (2) a collective 19 action class of all Persons who were employed by Yelp as an Account Executive (including 20 positions incorporating the titles Account Executive, Account Executive Trainee, Associate 21 Account Executive Trainee, Associate Account Executive, Junior Account Executive, Sales 22 Associate, Sales Representative, and Senior Account Executive,) in the United States of America 23 outside of California during the three years prior to the date of preliminary approval (National 24 Class Period). 25

Solely for the purpose of settling this case, the parties stipulate and agree that the requirements for establishing class certification with respect to the California Class have been met and are met. If this Settlement is not approved by the Court for any reason, Yelp reserves its

rights to contest class certification.

This Stipulation, if approved by the Court, will result in the termination with
prejudice of the Litigation through the entry of the Judgment, and the release of all California
Released Claims for all California Settlement Class Members, and the release of all National
Released Claims for all National Settlement Class Members. The Class Representatives will also
execute a general release of all claims.

### IV. Defendant's Denial of Wrongdoing or Liability.

8 Yelp denies all of the claims and contentions alleged by the Class Representatives 9 in the Litigation. Nonetheless, Yelp has concluded that further conduct of the Litigation would be 10 protracted and expensive, and that it is desirable that the Litigation be fully and finally settled in 11 the manner and upon the terms and conditions set forth in this Stipulation. Yelp has also taken 12 into account the uncertainty and risks inherent in any litigation, especially in multi-party cases 13 like this Litigation. Yelp has therefore determined that it is desirable and beneficial to it that the 14 Litigation be settled in the manner and upon the terms and conditions set forth in this Stipulation.

15

### V. Claims of the Class Representatives and Benefits of Settlement.

The Class Representatives and Class Counsel believe that the claims presently 16 asserted in the Litigation have merit and that evidence developed to date supports the claims. 17 However, the Class Representatives and Class Counsel recognize and acknowledge the expense 18 and length of the type of continued proceedings necessary to prosecute the Litigation against Yelp 19 through trial and through appeals. The Class Representatives and Class Counsel have also taken 20 into account the uncertain outcome and the risk of any litigation, as well as the difficulties and 21 delays inherent in such litigation. Based upon their evaluation, the Class Representatives and 22 Class Counsel have determined that the settlement set forth in the Stipulation is in the best 23 interests of the Class Representatives, the California Class, and the National Class. 24

# Terms of Stipulation and Agreement of Settlement.

# 26

## NOW, THEREFORE, IT IS HEREBY FURTHER STIPULATED AND

AGREED by and between the Class Representatives (for themselves and the California
Settlement Class Members and/or National Settlement Class Members) and Yelp, with the

assistance of their respective counsel or attorneys of record, that, as among the Settling Parties,
including all California Settlement Class Members and National Settlement Class Members, the
Litigation and the California Released Claims and National Released Claims shall be finally and
fully compromised, settled, and released, and the Litigation and Counterclaim shall be dismissed
with prejudice, as to all Settling Parties, upon and subject to the terms and conditions of the
Stipulation and the Judgment.

Definitions.

1.

8 As used in all parts of this Stipulation, the following terms have the meanings9 specified below:

1.1 "Account Executive" means the position or job title of Account
 Executive as that term is commonly used at Yelp, and which specifically includes without
 limitation the positions with the specific titles: Account Executive, Account Executive Trainee,
 Associate Account Executive Trainee, Associate Account Executive, Junior Account Executive,
 Sales Associate, Sales Representative, and Senior Account Executive.

1.2 "California Class" means the collective group of Persons who were
 employed by Yelp as an Account Executive in California at any point during the California Class
 Period. The California Class is a Rule 23 opt-out class, and it does not include Persons who were
 never employed by Yelp as Account Executives in California during the California Class Period.
 Yelp has represented and Class Representatives and Class Counsel understand that this California
 Class consists of 488 people.

1.3 "California Class Member" or "Member of the California Class" means
a Person who is a member of the California Class.

1.4 "California Class Period" means the period from March 29, 2007
through and including December 31, 2011.

1.5 "California Participating Claimant" means each Member of the
California Class who submits a Qualifying California Claim Form in response to the California
Notice. If fewer than fifty percent (50%) of the Qualifying California Work Weeks are claimed,
the additional money that would have been paid by Yelp if fifty percent (50%) of the Qualifying

California Work Weeks had been claimed shall be distributed pro rata to the California
 Participating Claimants according to their individual Qualifying California Work Weeks.

1.6 "California Released Claims" collectively means any and all claims, 3 including Unknown Claims as defined in Paragraph 1.56 hereof, demands, rights, liabilities and 4 5 causes of action of every nature and description whatsoever, including without limitation statutory, constitutional, contractual or common law claims, whether known or unknown, whether 6 7 or not concealed or hidden, whether arising under federal or state law, against the Yelp Releasees, 8 or any of them, including without limitation claims for wages, damages, unpaid costs, penalties, 9 liquidated damages, punitive damages, interest, attorney fees, litigation costs, restitution, or 10 equitable relief, that accrued during the California Class Period as a result of the California Class Member's employment as an Account Executive in California for Yelp, based on the following 11 12 categories of claims or allegations: (a) any and all claims for (i) failure to pay wages for work 13 performed in excess of eight hours in a day or forty hours in a week, regular; and/or (ii) failure to 14 pay regular, overtime or other premium wages, failure to pay minimum wages, failure to provide 15 sufficient meal and/or rest periods and/or to pay premiums in lieu thereof, failure to comply with 16 payroll or wage record-keeping or itemization requirements, and failure to timely pay wages due 17 at termination or otherwise; (b) any and all claims alleging statutory violations arising from the 18 same categories of allegations set forth above in Paragraph 1.5(a), including without limitation 19 claims under the Fair Labor Standards Act ("FLSA"), the Portal to Portal Act, California Labor 20 Code sections 218, 226, 226.7 and 1194 and California Business & Professions Code sections 21 17200 et seq.; (c) any and all claims for penalties or liquidated damages or other available 22 remedies arising from the categories of allegations set forth above in Paragraph 1.5(a) and (b), 23 including without limitation claims under the FLSA, Portal to Portal Act, California Labor Code 24 sections 203, 226, 226.7, 512, 1194, and 2698 et seq., and applicable California Industrial 25 Welfare Commission Wage Orders; and (d) any and all claims for interest, costs, or attorney fees 26 arising from the categories of allegations set forth above in Paragraph 1.5(a) and (b), including 27 without limitation claims under the California Labor Code sections 218.5, 1194, and 2699(g)(1), 28 California Code of Civil Procedure section 1021.5, and Federal Rule of Civil Procedure 23(h);

and (e) to the extent not covered by the above, any and all claims pled in the Litigation. (The 1 Settling Parties understand and agree that the California Released Claims include claims under 2 the California Private Attorney Generals Act of 2004, codified at California Labor Code sections 3 2698 et seq., for which the California Class was granted additional consideration, which is 4 already part of, and not in addition to, the Maximum Settlement Amount, in the amount of 5 \$7,500, which shall be paid to the California Labor and Workforce Development Agency 6 pursuant to this settlement. The Settling Parties further agree and understand that 7 notwithstanding the foregoing, California Settlement Class Members who do not become 8 California Participating Claimants will not be deemed to have released direct FLSA claims (as 9 opposed to indirect FLSA claims, such as a claim under the California Unfair Competition Law, 10 codified at California Business and Professions Code section 17200, predicated on an alleged 11 violation of the FLSA, which will be released and waived), but will be deemed to have and will 12 have released all other California Released Claims. 13

1.8 "California Settlement Class" means the collective group of all of the

 occurs, regardless of whether they submit California Claim Forms.

1.9 "California Settlement Class Member" or "Member of the California
Settlement Class" means any Person who is a member of the California Settlement Class.

1.10 "California Settlement Sum" means the total, gross amount due to an
individual California Participating Claimant, which shall be the product of the California
Settlement Sum Variable multiplied by the number of Qualifying California Work Weeks worked
by that California Participating Claimant. Because of the withholdings described in Paragraphs

2.1.2 and 2.2.1, the net amount ultimately received by each California Participating Claimant may
 be less than his or her gross California Settlement Sum.

1.11 "California Settlement Sum Variable" means the number which is the

(after adjustment for un-awarded fees, costs or enhancements) divided by the total number of
Qualifying California Work Weeks in the California Class Period for all California Class
Members, regardless of whether they actually become California Participating Claimants or
remain California Class Members.

9 1.12 "Claims Administrator" means the third-party claims administration firm
10 of Simpluris, unless another administrator is agreed upon by the Settling Parties in writing prior
11 to the preliminary approval of the settlement.

1.13 "Class Counsel" means, collectively, the law firms of Rukin, Hyland,
 Doria & Tindall, LLP; Gallenberg PC; and Shapiro Haber & Urmy LLP .

14 1.14 "Class Representatives" or "the Class Representatives" means Justin
15 Larkin, Anthony Tijerino, and Ahmad Deanes, plaintiffs in the Litigation.

16 1.15 "Yelp" means Yelp! Inc., a corporation and the defendant in the
Litigation. "Yelp Releasees" means Yelp and each of its parents, affiliates, subsidiaries,
predecessors, successors, divisions, joint ventures and assigns and each of these entities' past or
present owners, directors, officers, employees, partners, members, principals, agents, insurers, coinsurers, re-insurers, shareholders, attorneys, employee benefit plans, employee benefit plan
trustees, fiduciaries, and administrators, and personal or legal representatives.

1.16 "Court" means the United States District Court for the Northern District
of California.

1.17 "Effective Date" means the date on which the Judgment becomes Final.

Yelp shall pay the 1 Payroll Taxes on the wage portion of these payments, provided that (a) if California Participating 2 Claimants claim more than seventy-five percent of the available California Qualifying Work 3 Weeks, then the Settlement Sums of all California Participating Claimants shall be adjusted 4 downward to offset one quarter (25%) of the cost to Yelp of the Payroll Taxes for those 5 individuals; (b) if National Participating Claimants claim more than seventy-five percent of the 6 available National Qualifying Work Weeks, then the Settlement Sums of all National 7 Participating Claimants shall be adjusted downward to offset one quarter (25%) of the cost to 8 Yelp of the Payroll Taxes for those individuals. 9

2.1.2 As further detailed in this Section 2, Yelp, itself or through the Claims
Administrator, will report each payment made pursuant to this Section 2 to government
authorities, including the Internal Revenue Service, as required by law, and it shall make all
required deductions and/or withholdings.

The only California Class Members entitled to any payment under this 14 2.1.3 Stipulation and the associated Judgment are California Participating Claimants, and they shall be 15 entitled to their respective California Settlement Sums only. The only National Class Members 16 entitled to any payment under this Stipulation and the associated Judgment are National 17 Participating Claimants, and they shall be entitled to their respective National Settlement Sums 18 only. With respect to the California Class only, and as set forth above in Paragraph 1.4, the 19 Settling Parties agree to a "participation floor" of fifty percent (50%), i.e., if fewer than fifty 20 percent (50%) of the Qualifying California Work Weeks are claimed, then the additional money 21 beyond that claimed that would have been paid if fifty percent (50%) of the Qualifying California 22 Work Weeks were claimed will be distributed pro rata to the California Participating Claimants 23 pursuant to their number of Qualifying California Work Weeks. As a result, if this "participation 24 floor" is triggered, Yelp will pay a total of \$293,333 and no more to the California Participating 25 Claimants and for associated Payroll Taxes. Those parts of the Maximum Settlement Portion for 26 Payments to California Participating Claimants and the Maximum Settlement Portion for 27 Payments to National Participating Claimants that are neither claimed nor, in the case of the 28

California Class, subject to pro rata distribution because of the California Class fifty percent
 (50%) "participation floor" described in this paragraph shall remain the property of or revert to
 Yelp, and any finding to the contrary will be a ground for Yelp to void the settlement. This
 Stipulation and the associated Judgment do not and will not create any unpaid residue or unpaid
 residual, and no distribution of such shall be required. Any finding to the contrary will give Yelp
 the option to void this Stipulation.

### 2.2 Taxes

Those payments (or portions thereof) allocated to the settlement of 2.2.18 claims for unpaid wages (a) shall be subject to required withholdings and deductions, and so the 9 net amounts payable will be less than the gross amounts; and (b) shall be reported in the year of 10 payment as wage income to the California Participating Claimants and National Participating 11 Claimants on a Form W-2 or analogous form. Those payments (or portions thereof) allocated to 12 all other claims, including without limitations claims for penalties, liquidated damages, interest 13 and other non-wage recovery (a) shall not be subject to withholdings and deductions, and so the 14 net amounts payable will be equal to the gross amounts; and (b) shall be reported in the year of 15 payment as non-wage income to the California Participating Claimants and National Participating 16 Claimants on a Form 1099 or analogous form. Other than as set forth above, Yelp will not, unless 17 otherwise required by law, make, from the California Settlement Sum of each California 18 Participating Claimant or the National Settlement Sum of each National Participating Claimant, 19 any deductions, withholdings or additional payments, including without limitation, medical or 20 other insurance payments or premiums, employee 401(k) contributions or matching employer 21 contributions, wage garnishments, or charity withholdings, and entry of the Order of Final 22 Approval by the Court shall be deemed authority not to make such deductions, withholdings, or 23 additional payments. Any amount paid to California Participating Claimants or National 24 Participating Claimants shall not create any credit or otherwise affect the calculation of any 25 deferred compensation, benefit, or other compensation plan provided by Yelp. 26

27 2.2.2 Other than the withholding and reporting requirements set forth in
28 Paragraphs 2.1.2 and 2.2.1 and the employer's standard share of liability for Payroll Taxes on the

portions of the payments characterized as wage payments, the California Participating Claimants 1 and National Participating Claimants shall be solely responsible for the reporting and payment of 2 any federal, state and/or local income or other tax or any other withholdings, if any, on any of the 3 payments made pursuant to this Stipulation. Yelp makes no representations, and it is understood 4 and agreed that Yelp has made no representations, as to the taxability of any portions of the 5 settlement payments to any California Participating Claimants or National Participating 6 Claimants, the payment of any costs or attorney fee awards, any payments to the Class 7 Representatives, or any other payments made pursuant to this Stipulation. The California Notice 8 will advise California Class Members to seek their own tax advice prior to acting in response to 9 that notice, and the National Notice will advise National Class Members in the same manner. 10

Approval of Notice to the Classes and Scheduling of a Settlement

Within twenty-one (21) days of the final execution of this Stipulation, 13 2.3.1the Class Representatives and Yelp, through their counsel of record in the Litigation, shall file 14 this Stipulation with the Court and jointly move for preliminary approval of this Stipulation. Via 15 this submission, and a supporting motion, the Settling Parties, through their counsel of record, 16 will request that the Court enter the Preliminary Approval Order thereby scheduling the 17 Settlement Hearing for the purposes of determining the good faith with regard to the settlement, 18 granting final approval of the settlement, granting final approval of this Stipulation, and entering 19 Judgment. Via this same motion, the Class Representatives, through Class Counsel shall advise 20 the Court of the agreements set forth in Paragraphs 2.8.1, 2.8.2 and 2.8.3 this Stipulation. 21

22 2.3.2 Subject to Court availability, the Class Representatives and Yelp shall 23 endeavor to notice the joint motion for entry of the Preliminary Approval Order described in 24 Paragraph 2.3.1 for a hearing before the Court as soon as possible. Failure of the Court to enter 25 the Preliminary Approval Order in its entirety or in a substantially similar form following the full 26 efforts of the Settling Parties to obtain such entry will be grounds for the Settling Parties to 27 terminate the settlement and the terms of this Stipulation.

If the Court enters the Preliminary Approval Order more than twenty 2.3.3 1 (20) days after the hearing date for the motion for preliminary approval, Class Counsel and 2 counsel for Yelp shall meet and confer to reach agreement on any necessary revisions of the 3 deadlines and timetables set forth in this Stipulation. In the event that the Settling Parties fail to 4 reach such agreement, any of the Settling Parties may apply to the Court via a noticed motion for 5 modification of the dates and deadlines in this Stipulation, provided that such a request to the 6 Court may seek only reasonable modifications of the dates and deadlines contained in this 7 Stipulation and no other changes. 8

If the Court enters the Preliminary Approval Order, then at the resulting 2.3.4 9 Settlement Hearing, the Class Representatives and Yelp, through their counsel of record, shall 10 address any written objections from California Class Members or National Class Members, any 11 concerns from California Class Members or National Class Members who attend the hearing, and 12 any concerns of the Court. The Settling Parties shall and hereby do, unless provided otherwise in 13 this Stipulation, stipulate to final approval of this Stipulation and entry of the Judgment by the 14 Court. Unless the Stipulation is voided per its terms, the Settling Parties and their counsel will 15 seek approval of the Stipulation and entry of the Judgment by the Court. 16

17

### 2.4 *Notice to Class Members.*

If, by entering the Preliminary Approval Order, the Court provides 2.4.1 18 authorization to send the California Notice to California Class Members, and the National Notice 19 to National Class Members, Yelp, through the Claims Administrator, will facilitate the mailing of 20 the California Notice to all California Class Members, and the National Notice to all National 21 Class Members, at their Last Known Addresses. All the notices shall be mailed via first class 22 mail through the United States Postal Service, postage pre-paid. The California Notice shall 23 include, as attached forms, a pre-printed change of address form, a pre-printed California Claim 24 Form, and a postage pre-paid return envelope. The National Notice shall include, as attached 25 forms, a pre-printed change of address form and pre-printed National Opt In and Claim Form, and 26 a postage pre-paid return envelope. No other materials will be included with the mailings 27 enclosing these notices. No Settling Party shall send any materials to any California or National 28

Class Member, provided Class Counsel may respond to individual inquiries from California or
 National Class Members.

2.4.2 The California Notice and National Notice and their envelopes or
coverings shall be marked to denote the return address of the Claims Administrator as listed on
the California Claim Form.

Yelp shall prepare the name, Last Known Address, and number of 2.4.36 Qualifying Work Weeks for each California Class Member and National Class Member for the 7 Claims Administrator so that the Claims Administrator can calculate and state in the Notice each 8 individual's approximate potential number of California or National Qualifying Work Weeks, 9 engage in the processing and mailing of each California Notice and each National Notice, and 10 carry out the associated claims process. This information will not be provided to the Class 11 Representatives or Class Counsel. By preliminarily approving this settlement, the Court will be 12 deemed to have authorized Yelp to provide the Claims Administrator with the Social Security 13 Number of each California Class Member and National Class Member. The number of California 14 or National Qualifying Work Weeks and the associated calculation of Settlement Sums will be 15 determined by reference to Yelp's records, which shall be presumed to be correct. In the event 16 that a Class Member disputes his or her Settlement Sum or number of Qualifying Work Weeks, 17 the Claims Administrator shall consult with Yelp and provide it the opportunity to honor (with 18 notice to Class Counsel) the dispute and make the increased payment. If Yelp disputes the 19 challenge, the Settling Parties shall meet and confer in an effort to resolve the matter, and if they 20 are unable to do so, they shall seek a determination from the Claims Administrator as to the 21 proper Settlement Sum for the individual in question before raising any such issue with the Court. 22

23 2.4.4 Both the California Notice and the National Notice shall include
24 language stating that pertinent law requires Yelp to refrain from retaliating against any California
25 Class Member or National Class Member for any actions taken or not taken in response to the
26 notices or in regard to the Litigation, and that Yelp has agreed to abide by this obligation.

27 2.4.5 Prior to mailing the California Notice to each California Class Member,
28 the Claims Administrator shall include in the space provided on each such notice the number of

Qualifying California Work Weeks for the California Class Member and the anticipated per week variable, *i.e.*, the California Settlement Sum Variable as well as the anticipated, approximate Settlement Sum for that California Class Member. Prior to mailing the National Notice to each National Class Member, the Claims Administrator shall include in the space provided on each such notice the number of Qualifying National Work Weeks for the National Class Member, and the National Notice shall also state the National Settlement Sum Variable as well as the anticipated, approximate Settlement Sum for that National Class Member.

8 2.4.6 Prior to mailing the California Notice to each California Class Member
9 and the National Notice to each National Class Member, the Claims Administrator shall
10 undertake a Reasonable Address Verification Measure to ascertain the current accuracy of the
11 Last Known Address of each California Class Member and National Class Member. To the
12 extent this process yields an Updated Address, that Updated Address shall replace the Last
13 Known Address and be treated as the new Last Known Address for purposes of this Stipulation
14 and for subsequent mailings in particular.

15 2.4.7 The Notice Mailing Deadline is the last date for the Claims
16 Administrator to mail the California Notices to the Last Known Address of each California Class
17 Member, and the National Notices to the Last Known Address of each National Class Member.

2.4.8 All costs of the mailing described in Paragraph 2.4.1 (including, for
example, the fees charged by the Claims Administrator, the cost of the envelopes in which the
California Notice and National Notice will be mailed, the cost of reproducing the California
Notice and National Notice, and the cost of postage to send the California Notice and National
Notice), shall be included in the portion of the Maximum Settlement Amount allocated for claims
administration costs.

24 2.4.9 Unless the Claims Administrator receives a California Notice or
25 National Notice returned from the United States Postal Service for reasons discussed below in
26 this paragraph, each California Notice and National Notice shall be deemed mailed and received
27 by the California Class Member or National Class Member upon mailing. In the event that
28 subsequent to the first mailing of a California Notice or National Notice, and prior to the Notice

Response Deadline, a Notice is returned to the Claims Administrator by the United States Postal 1 Service with a forwarding address for the recipient, the Claims Administrator shall re-mail that 2 Notice to the forwarding address, that Notice will be deemed mailed and received at that point, 3 and the forwarding address shall be deemed the Updated Address for that California Class 4 5 Member or National Class Member. In the event that subsequent to the first mailing of a California Notice or National Notice, and prior to the Notice Response Deadline, a Notice is 6 returned to the Claims Administrator by the United States Postal Service because the address of 7 the recipient is no longer valid, *i.e.*, the envelope is marked "Return to Sender," the Claims 8 Administrator shall undertake another Reasonable Address Verification Measure to attempt to 9 10 ascertain the current address of the particular California Class Member or National Class Member in question and, if such an address is ascertained, the Claims Administrator will re-send that 11 12 Notice within five (5) days of receiving such information, and if no address is obtained through this process, then the Claims Administrator shall attempt to ascertain the specific Class Member's 13 14 address through the use of a standard skip trace procedure (such as Lexis/Nexis Accrunit). If no Updated Address is obtained for that California Class Member or National Class Member through 15 this second effort, the Notice shall be sent again to the Last Known Address, and in either event, 16 17 the Notice shall be deemed received once it is mailed for the second time. In the event that 18 subsequent to the second mailing of a Notice, and on or after the Notice Response Deadline, a 19 Notice is returned to the Claims Administrator by the United States Postal Service because the address of the recipient is no longer valid, *i.e.*, the envelope is marked "Return to Sender," the 20 Claims Administrator shall be required to take no further action with that Notice and it shall be 21 22 deemed to have been delivered. Nothing in this Paragraph 2.4.9 shall be deemed to extend the Notice Response Deadline. 23

24 2.4.10 To the extent a Class Member has not submitted to the Claims
25 Administrator some form of written response to the Class Notice, i.e., a change of address form,
26 an opt out or a claim form, by the date that is fifteen (15) days before the Notice Response
27 Deadline, the Claims Administrator shall send that Class Member a postcard (a) referencing the
28 name of the Litigation; (b) stating that the Class Member previously received a notice in this

action; and (c) providing a physical and email address for the Claims Administrator and stating 1 that the Class Member can write the Claims Administrator to receive an additional copy of the 2 notice. The postcard shall not contain additional information or statements. Nothing in this 3 Paragraph 2.4.10 shall be construed to extend the Notice Response Deadline for any Class 4 Member. To the extent that by the date that is fifteen (15) days before the Notice Response 5 Deadline, Qualifying California Settlement Claim Certification Forms have been received with 6 respect to fewer than fifty (50%) of the Qualifying California Work Weeks, then the Claims 7 Administrator shall provide Class Counsel with a randomly generated list of the names (and only 8 the names) of one hundred (100) Class Members who have, as of that point, not yet filed a Claim 9 Certification Form or other response to the notice, provided if such information is provided, Class 10 Counsel agrees (a) to keep such names confidential and use them only for purposes of the 11 Litigation, e.g., communications to ensure the notice process was effective, and (b) not to initiate 12 contact or communicate with any Class Members while they are at work, i.e., initiate contact with 13 them through a physical Yelp office address or a Yelp email account. 14

2.5 *Responses to the California Notice and National Notice; Motion for Final Approval.* 

California Class Members may elect to "opt out" of the California 2.5.1 17 Settlement Class and thus exclude themselves from the California Settlement Class. California 18 Class Members who wish to exercise this option must mail to the Claims Administrator a timely 19 written request Opt Out. If an Opt Out is not received by the Claims Administrator from a 20 California Class Member postmarked on or before the Notice Response Deadline, then that 21 California Class Member will be deemed to have forever waived his or her right to opt out of the 22 California Settlement. California Class Members who do not properly submit Opt Outs shall be 23 deemed Members of the California Settlement Class. California Class Members who do properly 24 submit Opt Outs and become Non-Settlement Class Members shall have no further role in the 25 Litigation, and for all purposes they shall be regarded as if they never were parties to this 26 Litigation. 27

2.5.2 National Class Members shall be excluded from the National 1 Settlement Class unless they elect to "opt in" to the National Settlement Class. National Class 2 Members who wish to exercise this option, *i.e.*, wish to opt in, can do so by timely and fully 3 completing, executing, and mailing, per the instructions therein, the form entitled "National Opt 4 In and Settlement Claim Certification Form" attached to the National Notice as Form B. Only 5 Participating National Class Members shall be deemed National Settlement Class Members, and 6 they shall be deemed to have opted into the case for purposes of the FLSA and Portal to Portal 7 Act, and they shall be the only National Class Members subject to the Judgment. Only those 8 National Settlement Class Members who submit Qualifying National Opt In and Claim Forms 9 shall be deemed National Participating Claimants, and they shall be the only National Class 10 Members entitled to receive payment pursuant to the settlement. It is agreed and understood that 11 if all National Class Members submit Qualifying National Opt In and Claim Forms to become 12 National Settlement Class Members and National Participating Claimants, Yelp will pay the 13 Maximum Settlement Portion for Payments to National Participating Claimants to all National 14 Participating Claimants, subject to adjustment for Payroll Taxes, but if fewer than one hundred 15 percent (100%) of National Class Members become National Settlement Class Members and 16 National Participating Claimants, then Yelp will pay less than the Maximum Settlement Portion 17 for Payments to National Participating Claimants to all National Participating Claimants. 18 National Class Members who do not submit National Opt In and Claim Forms shall be excluded 19 from the National Settlement Class, shall be deemed to have forever waived their rights to be 20 National Participating Claimants and to receive payment under this settlement, shall have no 21 further role in the Litigation, and for all purposes shall be regarded as if they never were parties to 22 this Litigation. 23

24 2.5.3 California Class Members who have not filed a valid Opt Out may seek
25 to become California Participating Claimants. California Class Members who wish to exercise
26 this option and certify their entitlement to payment under the settlement must fully complete,
27 execute, and mail, per the instructions therein, the form entitled "California Settlement Claim
28 Certification Form" attached to the California Notice as Form B. If a Qualifying California

- 26 -

1 Settlement Claim Certification Form is not received by the Claims Administrator from a 2 California Class Member postmarked on or before the Notice Response Deadline, then that 3 California Class Member will be deemed to have forever waived his or her right to be a California 4 Participating Claimant and receive payment under this settlement. As long as they do not properly submit Opt Outs, California Class Members who do not submit Qualifying California 5 6 Settlement Claim Certification Forms in a timely and proper fashion shall be deemed Members of 7 the California Settlement Class and shall be subject to the Judgment. Only California 8 Participating Claimants shall be entitled to payment pursuant to the Judgment. It is agreed and understood that if all California Class Members become California Participating Claimants, then 9 10 Yelp will pay the Maximum Settlement Portion for Payments to California Participating Claimants to all California Participating Claimants, subject to adjustment for Payroll Taxes, but if 11 fewer than one hundred percent (100%) of California Class Members become California 12 Participating Claimants, then Yelp will pay less than the Maximum Settlement Portion for 13 14 Payments to California Participating Claimants to the California Participating Claimants.

2.5.4 California Class Members who have not filed a valid Opt Out and
National Class Members have the option to participate in this Litigation at their own expense by
obtaining their own attorney(s). California Class Members and National Class Members who
choose this option will be responsible for any attorney fees or costs incurred as a result of this
election. The California Notice and the National Notice will advise California Class Members
and National Class Members of this option.

21 2.5.5 California Class Members who have not filed a valid Opt Out and all 22 National Class Members may object to the Stipulation by submitting written objections to Class 23 Counsel (either directly or via the Claims Administrator) no later than the Notice Response Deadline. The California Notice and the National Notice shall advise California Class Members 24 25 and National Class Members of this option. Class Counsel shall immediately provide any such 26 objections to Yelp and subsequently the Court during the final approval process. The Settling 27 Parties agree to respond to any objections at a hearing before the Court. California Class 28 Members who have not filed a valid Opt Out and all National Class Members may object to Class Counsel's request for attorneys' fees within ten (10) days of Class Counsel's motion for such fees.

To the extent that a California Class Member or National Class 2.5.6 3 Member timely submits an incomplete California Claim Form or National Opt In and Claim Form 4 (i.e., not all spaces have been completed), the Claims Administrator shall send that person a "cure 5 letter" advising him or her of the deficiency and giving him or her the opportunity to correct the 6 deficiency no later than the Notice Response Deadline or fifteen (15) days after the cure letter is 7 sent, whichever is later, provided this paragraph shall in no way extend the Notice Response 8 Deadline for any California Class Members or National Class Members to whom a cure letter is 9 not sent. If no response to this cure letter is received, the Settlement Parties shall meet and confer 10 to determine if the original California Claim Form or National Opt In and Claim Form was indeed 11 deficient, and the submission of an incomplete California Claim Form or National Opt In and 12 Claim Form will create a presumption that the Class Member intended to become a Participating 13 Claimant. To the extent that a California Class Member timely submits both an Opt Out and a 14 Qualifying California Claim Form (i.e., contradictory forms), the Claims Administrator shall send 15 that person a "cure letter" advising him or her of the contradiction and giving him or her the 16 opportunity to select which form should be deemed submitted, and if no response is received, the 17 California Class Member shall be deemed a California Participating Claimant. 18

California Class Members and National Class Members who, for future 2.5.719 reference and mailings from the Court or Claims Administrator, if any, wish to change the name 20 or address listed on the envelope in which the California Notice or National Notice was first 21 mailed to them, must either (a) add their new address information to a timely submitted Opt Out, 22 California Claim Form, or National Opt In and Claim Form; or (b) fully complete, execute, and 23 mail, per the instructions therein, the form entitled "Change of Name or Address Information" 24 attached to both the California Notice and the National Notice as Form A. All name or address 25 change requests must be postmarked or received on or before the Notice Response Deadline. To 26 the extent that a California Class Member or National Class Members requests a replacement 27

California or National Notice or associated forms prior to the Notice Response Deadline, the
 Claims Administrator shall provide them.

Prior to the Settlement Hearing and consistent with the rules imposed 2.5.8 3 by the Court, the Class Representatives and Yelp shall jointly move the Court for entry of the 4 Order of Final Approval (and the associated entry of Judgment). Through this motion, the 5 Settling Parties shall advise the Court of the agreements in Paragraphs 2.8.1, 2.8.2, and 2.8.3 of 6 this Stipulation. The Class Representatives and Class Counsel shall be responsible for justifying 7 the agreed upon payments set forth in Paragraphs 2.8.1, 2.8.2, and 2.8.3 of this Stipulation. To 8 the extent possible, the motion seeking entry of the Order of Final Approval shall be noticed for 9 the same day as the Settlement Hearing. The Settling Parties shall make all reasonable efforts to 10 secure entry of the Order of Final Approval. If the Court rejects the Stipulation, or fails to 11 approve enter the Order of Final Approval, or enter the Judgment, this Stipulation shall be void 12 *ab initio*, and Yelp shall have no obligations to make any payments under the Stipulation. In the 13 event that the Stipulation becomes void for this or any other reason, Yelp retains all rights to 14 challenge all claims and allegations in the Litigation upon all procedural and factual grounds, 15 including without limitation the ability to challenge class or collective action treatment on any 16 grounds or assert any and all defenses or privileges. 17

18

#### 2.6 *Timing of Payment to Claimants.*

2.6.1 Within thirty (30) days of, and only after, the Effective Date, Yelp,
 through the Claims Administrator, shall pay to each California Participating Claimant his or her
 relevant California Settlement Sum and shall pay through the Claims Administrator to each
 National Participating Claimant his or her relevant National Settlement Sum.

2.6.2 In accordance with the terms of Paragraphs 2.1.1 and 2.1.2, Yelp,
through the Claims Administrator, shall issue to each California Participating Claimant and
National Participating Claimant one check (or more if necessary for administrative convenience)
payable to that Claimant from an account administered by the Claims Administrator but funded
by Yelp for the gross amount of his or her California Settlement Sum or National Settlement
Sum, less relevant withholdings. Yelp, through the Claims Administrator, shall mail this check(s)

to each California Participating Claimant and National Participating Claimant at his or her Last 1 Known Address, or Updated Address if obtained, on or before the date which is thirty (30) days 2 after the Effective Date. Checks issued to California Participating Claimants and National 3 Participating Claimants pursuant to this Agreement shall remain negotiable for a period of at least 4 ninety (90) days from the date of mailing. If a check has not been cashed within sixty (60) days 5 of issuance, the Claims Administrator shall send the Class Member in question a postcard 6 reminder about the deadline for cashing the check and information on how to request a 7 replacement check. The funds associated with any checks that are not properly or timely 8 negotiated shall revert to Yelp, which shall then, within thirty (30) days, donate such funds to the 9 Volunteer Legal Services Program of the Bar Association of San Francisco. The Settling Parties 10 hereby agree that such funds represent settlement payments for matters disputed in good faith, not 11 uncontested wage payments, and they shall not be subject to escheat rules, cy pres, or other 12 distribution not provided for in this Stipulation. California Participating Claimants and National 13 Participating Claimants who fail to negotiate their settlement checks in a timely fashion shall 14 remain subject to the terms of the Judgment. 15

Following the mailing of the payments pursuant to Paragraph 2.6.2, the 2.6.3 16 Claims Administrator shall provide counsel for the Settling Parties with a written confirmation 17 that such payments have been made. Upon receipt of this confirmation, Class Counsel will file a 18 notice or acknowledgement of satisfaction of judgment with the Court in the Litigation on behalf 19 of the Class Representatives and the California Settlement Class and National Settlement Class. 20

21

#### Releases and Dismissals. 2.7

Upon the Effective Date, Class Representatives Larkin, Tijerino, and 2.7.1 22 Deanes and each of the California Settlement Class Members shall be deemed to have, and by 23 operation of the Judgment shall have, fully, finally, and forever released, dismissed with 24 prejudice, relinquished, and discharged all California Released Claims. Upon the Effective Date, 25 the Class Representatives and each of the National Settlement Class Members shall be deemed to 26 have, and by operation of the Judgment shall have, fully, finally, and forever released, dismissed 27 with prejudice, relinquished, and discharged all National Released Claims. 28

This settlement shall result in the release by the California Settlement 2.7.2 1 Class Members of all California Released Claims under the California Private Attorneys General 2 Act of 2004 ("PAGA"), codified at California Labor Code section 2698 et seq. The Settling 3 Parties agree that Yelp's payment of \$7,500 to the California Labor Workforce Development 4 Agency (as part of the Maximum Settlement Amount) to settle these claims is appropriate and 5 proper consideration. As part of this settlement, and subject to Court approval, Yelp will pay 6 through the Claims Administrator \$7,500 out of the Maximum Settlement Amount to the 7 California Labor and Workforce Development Agency. It is the intent of the Settling Parties to 8 9 have the Released Claims include PAGA claims.

10

## 2.8 *Payment of Costs, Attorney Fees and Class Representatives Enhancements.*

Class Counsel shall be entitled, subject to Court approval and the 2.8.1 12 occurrence of the Effective Date, to an award of reasonable attorney fees and litigation costs and 13 associated expenses, not to exceed the amounts specified herein. Subject to Court approval, Class 14 Counsel may collectively seek a gross amount up to, but not to exceed, \$312,500 for all attorney 15 fees, and a gross amount up to, but not to exceed, \$10,000 for all allowable litigation costs and 16 associated expenses. The Class Representatives and Class Counsel agree that they shall be 17 responsible for justifying their requested fee, cost, and expense awards to the Court, and they 18 agree to submit the necessary materials to justify the requested award along with the Settling 19 Parties' joint motion for final approval of the Stipulation pursuant to Paragraph 2.5.8. Yelp 20 agrees not to oppose any submission regarding, or request for approval of, an award of attorney 21 fees, costs, and expenses, provided that it is consistent with this Paragraph 2.8.1 of this 22 Stipulation and, in particular, provided that Yelp not be required to pay any more than \$322,500 23 in total to all Class Counsel for all attorney fees, costs, and expenses combined. In the event that 24 the Court (or appellate court) awards less than the \$312,500 maximum gross amount for attorney 25 fees, only the awarded amounts shall be paid and shall constitute full satisfaction of any claims 26 for attorney fees in this Litigation, and any remaining or unawarded portion of the maximum 27 gross amount for attorney fees shall be allocated two-thirds to the Maximum Settlement Portion 28

for Payments to California Participating Claimants and one-third to the Maximum Settlement 1 Portion for Payments to National Participating Claimants. In the event that the Court (or 2 3 appellate court) awards less than the \$10,000 maximum gross amount for litigation costs and associated expenses, only the awarded amounts shall be paid and any remaining or unawarded 4 5 portion of the maximum gross amount for litigation costs and associated expenses shall be allocated two-thirds to the Maximum Settlement Portion for Payments to California Participating 6 Claimants and one-third to the Maximum Settlement Portion for Payments to National 7 8 Participating Claimants. If the Effective Date occurs, no more than fourteen (14) days after the Effective Date, Yelp shall make payment of any attorney fees, costs, and expenses awarded by 9 the Court pursuant to this Paragraph 2.8.1 to Class Counsel directly, and prior to Yelp making 10 this payment, Class Counsel shall provide counsel for Yelp with the pertinent taxpayer 11 identification numbers for the payees and Form(s) W-9. Other than any reporting of this fee 12 payment as required by this Stipulation or law, which Yelp shall make, Class Counsel and the 13 Class Representatives shall alone be responsible for the reporting and payment of any federal, 14 15 state and/or local income or other form of tax on any payment made pursuant to this paragraph. Payments awarded and made pursuant to this paragraph shall constitute full satisfaction of any 16 claim for attorney fees, costs, or expenses incurred in this Litigation, and the Class 17 Representatives and Class Counsel, on behalf of themselves and all California Settlement Class 18 Members and National Settlement Class Members, agree that they shall neither seek nor be 19 entitled to any additional attorney fees, costs, or expenses under any theory, nor shall they seek 20 21 amounts in excess of those specified herein. Other than as provided in this Paragraph 2.8.1 for the limited purpose discussed herein, no party shall be deemed the prevailing party for any other 22 purposes of the Litigation. 23

24 2.8.2 Provided that the Effective Date occurs, and following and within
25 fourteen (14) days of the execution of the general releases discussed below, Yelp will forward a
26 check payable to Justin Larkin, in his personal capacity only and via his counsel of record, in the
27 gross amount of five thousand United States dollars (\$5,000); will forward a check payable to
28 Anthony Tijerino, in his personal capacity only and via his counsel of record, in the gross amount

of five thousand United States dollars (\$5,000); and will forward a check payable to Ahmad 1 Deanes, in his personal capacity only and via his counsel of record, in the gross amount of five 2 thousand United States dollars (\$5,000). These payments shall be the total compensation and 3 consideration for: (i) Justin Larkin's, Anthony Tijerino's, and Ahmad Deanes's efforts as the 4 5 Class Representatives in the Litigation; and (ii) their execution of a full, general release to the benefit of Yelp. The full and general release that Justin Larkin, Anthony Tijerino, and Ahmad 6 7 Deanes shall execute to obtain payment pursuant to this Paragraph 2.8.2 shall be executed 8 immediately following the Effective Date, and through it, Justin Larkin, Anthony Tijerino, and 9 Ahmad Deanes (and not on behalf of the California Class or National Class or any members of 10 those classes) shall release, acquit, and discharge Yelp from any and all claims, demands, claims 11 for costs and attorney fees, or causes of action of any kind whatsoever (upon any legal or 12 equitable theory whether contractual, common law, statutory, Federal, State or otherwise), whether known or unknown, that arose, accrued or took place at any time on or prior to the date 13 on which the full and general release is executed, including without limitation all claims pled in 14 the Litigation, which will also be dismissed with prejudice per the Judgment. Through the full 15 and general release discussed in this Paragraph 2.8.2, Justin Larkin, Anthony Tijerino, and 16 17 Ahmad Deanes will expressly waive the benefit of Section 1542 of the California Civil Code, and will agree and represent that he has not assigned or in any way conveyed, transferred or 18 encumbered all or any portion of the claims or rights otherwise released. If either Justin Larkin, 19 20 Anthony Tijerino, and Ahmad Deanes do not execute the full and general release discussed in this Paragraph 2.8.2, with all of the specific terms required herein, Yelp shall not be required to make 21 22 any payment whatsoever to the person who does not execute the full and general release pursuant to this Paragraph 2.8.2. These enhancement awards of \$5,000 are separate from payment of 23 24 whatever California Settlement Sum and National Settlement Sum to which Justin Larkin, 25 Anthony Tijerino, and Ahmad Deanes are entitled to under this Stipulation. Justin Larkin and 26 Anthony Tijerino shall be deemed California Participating Claimants and Ahmad Deanes shall be 27 deemed a National Participating Claimant such that they will not be sent Class Notices. The full 28 and general release discussed in this paragraph shall not extinguish or alter the obligations of

Yelp to the California Class Members or National Class Members under any other paragraph of
this agreement. In the event that the Court (or appellate court) awards less than the \$5,000
enhancement award to either Justin Larkin, Anthony Tijerino, or Ahmad Deanes in consideration
for a general release and as a Class Representatives enhancement award, the un-awarded portion
of any \$5,000 enhancement award shall be allocated two-thirds to the Maximum Settlement
Portion for Payments to California Participating Claimants and one-third to the Maximum
Settlement Portion for Payments to National Participating Claimants.

8 2.8.3 Unless otherwise expressly provided, Yelp shall have no responsibility
9 for, and no liability whatsoever with respect to, the allocation among Justin Larkin, Anthony
10 Tijerino, Ahmad Deanes, Class Counsel, and/or any other Person who may assert some claim
11 thereto, of any award or payment issued or made in the Litigation or pursuant to this Stipulation,
12 including, but not limited to, any award or payment made pursuant to Paragraph 2.8.1. or 2.8.2.

13

2.9 *Claims Administrator.* 

All fees and expenses reasonably incurred by the Claims Administrator
as a result of procedures and processes expressly required by this Stipulation shall be paid by
Yelp and taken from the Maximum Settlement Amount. The Class Representatives and Class
Counsel shall have no responsibility for such fees or expenses, whether or not the Effective Date
occurs. The total amount charged by the Claims Administrator shall not exceed \$25,000.

The actions of the Claims Administrator shall be governed by the terms 2.9.2 19 of this Stipulation. The Settling Parties shall work cooperatively to ensure that the Claims 20 Administrator receives information necessary to carrying out its responsibilities. The Claims 21 Administrator shall, on a reasonable basis, keep Class Counsel and Yelp's Counsel apprised of its 22 progress, its efforts, and of the response from Class Members and of any other communications 23 received by members of the Class, concerning the settlement. The Claims Administrator shall 24 provide the Court, at least ten (10) days prior to the Final Approval Hearing, a declaration of due 25 diligence and proof of mailing with respect to (i) the mailing of the California Notice and Claim 26 Form, and National Notice and Opt-In Form, (ii) attempts to locate Class members, and (iii) the 27 number of Class Members for whom the Notices were undeliverable. 28

1 2.9.3 In the event that any of the Settling Parties take the position that the 2 Claims Administrator is not acting in accordance with the terms of the Stipulation, that party's 3 counsel shall meet and confer with counsel for the other Settling Parties prior to raising any such 4 issue with the Claims Administrator or the Court.

5

### 2.10 Termination or Voidance of Settlement or Stipulation

2.10.1 In the event that the Stipulation is not substantially approved by the 6 7 Court or the settlement set forth in the Stipulation is terminated, cancelled, declared void or fails 8 to become effective in accordance with its terms, or if the Judgment does not become Final, or to 9 the extent termination, cancellation or voiding of the Stipulation occurs as otherwise provided in 10 this Stipulation or for any other lawful or permissible reason, the Settling Parties shall resume the Litigation at that time as if no Stipulation had been entered, with each of the Settling Parties 11 12 bearing their own costs and fees with regard to the efforts to obtain Court approval, and no 13 payments whatsoever being made by Yelp to anyone in accordance with the terms of this Stipulation, except that Yelp will be responsible for any reasonable costs incurred by the Claims 14 15 Administrator to the point the Stipulation is deemed void. In such event, any Judgment or order entered by the Court in accordance with the terms of the Stipulation shall be treated as vacated 16 17 nunc pro tunc, and the Stipulation shall have no further force and effect with respect to the 18 Settling Parties, and shall not be used in this Litigation or in any other proceeding for any 19 purpose, including in relation to issues of class or collective action certification. Specifically, the 20 Class Representatives and Class Counsel agree not to argue or present any argument, and hereby 21 waive any argument, that this Stipulation precludes Yelp from contesting class or collective 22 action certification on any grounds if this Litigation were to proceed; this Stipulation shall not be 23 deemed an admission by, or ground for estoppel against, Yelp that class or collective action 24 certification in the Litigation is proper or cannot be contested on any grounds. The terms, 25 negotiation, and entry of this Stipulation and the settlement shall remain subject to Federal Rule 26 of Evidence 408 and California Evidence Code sections 1119 and 1152, regardless of if this 27 Stipulation or the settlement are terminated, cancelled, or declared void.

2.10.2 If the Court changes the dates of hearings provided for in this
 Stipulation by fewer than three (3) months, this shall not be deemed a substantial change
 necessitating termination of the settlement, providing that the Settling Parties agree to move other
 dates and deadlines in the Stipulation accordingly.

2.10.3 In the event that more than ten percent (10%) of California Class
Members opt out of the California Settlement Class by submitting Opt Outs pursuant to
Paragraph 2.5.1, Yelp shall have the right (but shall not be required) to terminate and void this
settlement and Stipulation.

Notwithstanding any other provision of this Stipulation, no order of the 9 2.10.4Court or modification or reversal on appeal of any order of the Court concerning the amount or 10 allocation of any attorney fee or litigation cost or expense awards or class representative 11 enhancement award to be paid by Yelp shall constitute grounds for cancellation or termination of 12 the Stipulation or grounds for limiting any other provision of the Judgment, provided that Yelp 13 shall never be required to pay in excess of the total gross amounts for attorney fees and litigation 14 costs and expenses and enhancements awards specified in Paragraphs 2.8.1 and 2.8.2. It is further 15 agreed that no order of the Court, including any order concerning attorney fees, may alter the 16 California Settlement Sum Variable or the National Settlement Sum Variable, or otherwise 17 increase any of the specific figures set forth in the Maximum Settlement Amount. 18

2.10.5 Any finding that California Code of Civil Procedure section 384
applies to this Stipulation to require payment by Yelp to any third parties is grounds for Yelp to
void the settlement.

22 2.10.6 Unless otherwise ordered by the Court, in the event the Stipulation
23 shall be terminated, cancelled, or declared void, or fails to become effective in accordance with
24 its terms, or if the Judgment is reversed on appeal, within thirty (30) days after written
25 notification of such event, Yelp and Class Counsel shall notify each other of this event in writing.

26

2.11 *Miscellaneous Provisions.* 

27 2.11.1 No Person shall have any claim against Class Counsel, the Claims
28 Administrator, or counsel for Yelp based on the payments made or other actions taken

substantially in accordance with the Stipulation and the settlement contained therein or further orders of the Court.

2.11.2 The Settling Parties (a) acknowledge that it is their intent to
consummate this agreement; and (b) agree to exercise their best efforts to obtain Court approval,
secure the effectiveness of the Judgment, and implement all terms and conditions of the
Stipulation.

2.11.3 The Stipulation compromises claims which are contested in good faith,
and it shall not be deemed an admission by any of the Settling Parties as to the merits of any
claim or defense. The Settling Parties agree that the amounts paid in settlement and the other
terms of the settlement were negotiated at arms-length and in good faith by the Settling Parties,
and reflect a settlement that was reached voluntarily after consultation with competent legal
counsel.

The Settling Parties agree that the Notice Response Deadline shall not 2.11.4 13 be extended, and no untimely submissions or claims will be honored, under any circumstances, 14 unless, and only unless, a California Class Member or National Class Member can sufficiently 15 demonstrate that his or her failure to respond to the pertinent California or National Notice was 16 the product of proven good cause, such as the fact that he or she was legally incompetent during 17 the notice response period, *i.e.*, he or she was incarcerated or hospitalized, or her or she was away 18 from his or her address for the entire notice period due to travel or a residence move; provided, 19 however, no untimely submissions or claims will be honored for any reason or under any 20 circumstances if they are not received by the Claims Administrator or Class Counsel prior to the 21 Settlement Hearing Motion Date. If there are disputes about whether a Class Member has proven 22 good cause to make an untimely submission, the Settling Parties shall meet and confer and 23 attempt to resolve the issue prior to raising it with the Court. The Settling Parties agree that the 24 establishment and enforcement of the Notice Response Deadline is valuable consideration to 25 Yelp, and the finality provided thereby is a material aspect of this agreement. Any ruling to the 26 contrary by the Court or any ruling allowing the filing of any responses to the California Notice 27

or the National Notice following the Notice Response Deadline shall be grounds for Yelp to void 2 the Stipulation.

Neither the Stipulation nor the settlement, nor any act performed or 2.11.5 3 document executed pursuant to, or in furtherance of, the Stipulation or the settlement: (a) is or 4 may be deemed to be or may be used as an admission of, or evidence of, the validity of any 5 Released Claim, or of any wrongdoing or liability of Yelp; or (b) is or may be deemed to be or 6 may be used as an admission of, or evidence of, any fault or omission of Yelp, in any civil, 7 criminal or administrative proceeding in any court, administrative agency, or other tribunal. 8

All of the exhibits to the Stipulation are material and integral parts 9 2.11.6 hereof and are fully incorporated herein by this reference. 10

The Stipulation may be amended or modified only by a written 2.11.7 11 instrument signed by or on behalf of all Settling Parties or their respective successors-in-interest. 12

The Stipulation constitutes the entire agreement among the Settling 2.11.8 13 Parties hereto and no representations, warranties, or inducements have been made to any party 14 concerning the Stipulation or its exhibits other than the representations, warranties, and covenants 15 contained and memorialized in such documents. Except as otherwise provided herein, each party 16 shall bear its own costs. 17

Class Counsel are expressly authorized by the Class Representatives to 2.11.9 18 take all appropriate action required or permitted to be taken by the California Class and National 19 Class pursuant to the Stipulation to effect its terms, and also are expressly authorized to enter into 20 any modifications or amendments to, or documents or pleadings filed in support of, the 21 Stipulation on behalf of the California Class and National Class which they deem appropriate. 22

Each counsel or other Person executing the Stipulation or any of its 2.11.10 23 exhibits on behalf of any party hereto hereby warrants that such Person has the full authority to do 24 25 so.

The Stipulation may be executed in one or more counterparts by email 26 2.11.11 or facsimile. All executed counterparts and each of them shall be deemed to be one and the same 27 instrument. A complete set of original executed counterparts shall be filed with the Court. 28

The Stipulation shall be binding upon, and inure to the benefit of, the 1 2.11.12 2 successors and assigns of the parties hereto; but this Stipulation is not designed to and does not 3 create any third party beneficiaries.

The Court shall retain jurisdiction with respect to implementation and 4 2.11.13 enforcement of the terms of the Stipulation, and all parties hereto submit to the jurisdiction of the Court for purposes of implementing and enforcing the settlement embodied in the Stipulation.

7 2.11.14 The Stipulation and the exhibits hereto shall be considered to have been 8 negotiated, executed, and delivered, and to have been wholly performed, in the State of 9 California, and the rights and obligations of the parties to the Stipulation shall be construed and enforced in accordance with, and governed by, the internal, substantive laws of the State of 10 California without giving effect to that State's choice of law principles. 11

12 2.11.15 The language of all parts of this Stipulation shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against either party. No 13 14 party shall be deemed the drafter of this Stipulation. The parties acknowledge that the terms of the Stipulation are contractual and are the product of negotiations between the parties and their 15 counsel. Each party and their counsel cooperated in the drafting and preparation of the 16 17 Stipulation. In any construction to be made of the Stipulation, the Stipulation shall not be construed against any party and the canon of contract interpretation set forth in California Civil 18 19 Code § 1654 and other similar statutory provisions shall not be applied.

20 2.11.16Yelp will not actively discourage Class Members or Class Member from becoming Participating Claimants nor will it retaliate against California Class Members or 21 22 National Class Members for any actions taken or not taken with respect to this settlement. Yelp will not sue the Class Representatives for filing the complaint in this Litigation, and in response 23 24 to any inquiry concerning the Class Representatives from a prospective employer to Yelp's 25 Human Resources Department, Yelp will provide a neutral statement regarding the Class 26 Representatives, *i.e.*, it will provide only their dates of employment and job title.

27 2.11.17 Yelp will not assert any claims against Class Counsel for their conduct in connection with the Litigation, and Yelp acknowledges that Class Counsel, and Class Counsel 28

acknowledge that Yelp's counsel, have complied with the requirements of Rule 11 of the Federal
 Rules of Civil Procedure to this point in the Litigation.

2.11.18 At no time shall the Claims Administrator or Yelp be requested or
required to provide Class Counsel or the Class Representatives with the Social Security Number,
Last Known Address, or other contact information of California Class Members and National
Class Members.

The Settling Parties agree to take all reasonable steps to comply with 2.11.19 7 the requirements of the Class Action Fairness Act of 2005, including the notice requirements. It 8 is the intent of the parties that the Judgment be binding on all California Settlement Class 9 Members and National Settlement Class Members. No more than ten (10) days after this 10 Stipulation and the joint motion for preliminary approval of this Stipulation is filed with the 11 Court, Yelp, itself or through the Claims Administrator, shall provide notice of this Stipulation as 12 set forth below to the Attorney General of the United States, the Attorney Generals of each state 13 in which Yelp employed Class Members, the California Department of Industrial Relations and 14 the California Labor and Workforce Development Agency, and any other entities or agencies that 15 Yelp deems appropriate. Said notice shall be mailed, can be in an electronic or disc format, and 16 shall include to the extent then available and feasible: (1) the current complaint in the Litigation; 17 (2) the notice of motion and motion for preliminary approval of the settlement, which shall 18 include the proposed final approval hearing date and shall confirm that there are no additional 19 agreements among the Settling Parties not reflected in the Stipulation; (3) the California Notice 20 and the National Notice; (4) this Stipulation, which shall include the proposed Judgment; (5) the 21 names of each California Class Member and his or her projected number of Qualifying California 22 Work Weeks; and (6) the names of each National Class Member and his or her projected number 23 of Qualifying National Work Weeks. The Settling Parties agree that this notice shall be sufficient 24 to satisfy the terms of 28 U.S.C. § 1715, and that subject to the occurrence of the Effective Date, 25 this Stipulation and the associated Judgment shall be binding on all California Settlement Class 26 Members and National Settlement Class Members. 27

The parties to this agreement recognize and acknowledge that at the 2.11.20 1 time of the execution of this Stipulation, there are issues of law that may be unresolved which 2 could impact the claims at issue in the Litigation absent this Stipulation. The parties further 3 recognize that they are reaching this settlement in light of the risks created by these and all other 4 issues of unsettled law, and that all parties will take all efforts to enforce this Stipulation and 5 obtain Court approval for this settlement regardless of any subsequent legal developments. The 6 Settling Parties and Class Counsel agree that the proposed classes are receiving benefit from this 7 settlement by obtaining a settlement (and associated consideration) prior to such possible 8 developments, and the Settling Parties and their counsel agree not to argue otherwise or seek to 9 void this settlement or prevent court approval on the basis of any subsequent precedent. 10

Prior to the parties' joint submission of this Stipulation and settlement 2.11.21 11 agreement for preliminary approval by the Court, neither the Class Representatives nor Class 12 Counsel shall communicate any terms of this settlement to any third parties. Following the 13 submission for preliminary approval and thereafter, Class Representatives and Class Counsel 14 shall not publicize the settlement in this action or the terms thereof via (a) press releases; (b) 15 Internet postings except for simply posting publicly filed court documents; or (c) any form of 16 communications with the media. This shall not prohibit Class Counsel from (1) discussing this 17 case or any aspect of this settlement with the Class Representatives, any California Class Member 18 or National Class Member (absent or otherwise) in this case, or any court or opposing counsel; (2) 19 disclosing their mere status as counsel in the case; or (3) posting on Class Counsel's websites the 20 mere fact of a pending settlement and the relevant court documents. 21







The Court has considered the Stipulation Re: Settlement of Class and Collective Actions (and its exhibits), the submissions of counsel, and all other papers filed in this action. The matter having been submitted and good cause appearing therefore, the Court finds as follows:

All defined terms contained herein shall have the same
 meanings as set forth in the Stipulation Re: Settlement of Class and Collective
 Actions executed by the Settling Parties and filed with this Court (the
 "Stipulation");

The Class Representatives and Yelp, through their counsel of
 record in the Litigation and per the terms of the Stipulation, have reached an

The Court conditionally finds that, for the purposes of approving 3. 16 this settlement only and for no other purpose and with no other effect, the proposed 17 California Class meets the requirements for certification under Rule 23 of the 18 Federal Rules of Civil Procedure: (a) the proposed California Class is ascertainable 19 and so numerous that joinder of all members of the class is impracticable; (b) there 20 are questions of law or fact common to the proposed California Class; (c) the 21 claims of the Class Representatives Justin Larkin and Anthony Tijerino (the 22 "California Class Representatives") are typical of the claims of the members of the 23 proposed California Class; (d) the California Class Representatives will fairly and 24 adequately protect the interests of the proposed California Class Members; (e) a 25 class action is superior to other available methods for an efficient adjudication of 26 this controversy, especially given the settlement context here; and (f) the counsel of 27 record for the California Class Representatives are qualified to serve as counsel for 28

The moving parties have also presented to the Court for review a 13 plan to provide a California Notice to the Members of the proposed California 14 Class which sets out the terms of the settlement and the California Class Members' 15 options including, *inter alia*, their options (i) to opt out of the California Settlement 16 Class, (ii) to remain in the California Settlement Class and elect to be represented 17 by counsel of their choosing, (iii) to object to the terms of the settlement, and/or 18 (iv) to seek to become California Participating Claimants by submitting California 19 Settlement Claim Certification Forms. The California Notice will be mailed to all 20 California Class Members at their Last Known Addresses. The plan regarding 21 22 California Notices proposed by the Settling Parties is the best practical under the circumstances and satisfies pertinent due process requirements and the requirements 23 of Federal Rule of Civil Procedure 23; and 24

7. The moving parties have also presented to the Court for review a
plan to provide a National Notice to the Members of the proposed National Class
which sets out the terms of the settlement and the National Class Members' options
including, *inter alia*, their options (i) to refrain from acting and thereby exclude

 provisions in the Stipulation. Yelp shall provide the Claims Administrator with the

4. Yelp has agreed to pay Class Counsel their reasonable attorney
fees in this matter in the maximum total combined, gross amount not to exceed
\$312,500 as well as certain allowable costs in this matter up to the maximum gross
amount of \$10,000, and Yelp has agreed to pay enhancement awards in the total

In the event that the Effective Date 26 does not occur for any reason whatsoever, the Stipulation shall be deemed null and 27 void and shall have no effect whatsoever. 28

#### A. Summary of Settlement

**DESCRIPTION OF THE SETTLEMENT** 

17 On behalf of both a national and a California class, Plaintiffs Larkin and Tijerino have 18 reached a voluntary settlement agreement with Yelp. The total maximum amount of the 19 consolidated settlement is \$1,250,000, with approximately two-thirds of that amount allocated to 20 the resolution of the claims of the California Settlement Class. Yelp guarantees that it will pay a 21 minimum of fifty percent of the amount set aside for payments to the California Settlement 22 Class. This means that if less than half of the money available for such payments is claimed, i.e., 23 because other class members do not file claims, and you do file a claim, your settlement payment 24 will almost certainly increase.

Through this settlement, neither Yelp nor its employees have admitted any liability or
wrongdoing. A full copy of the settlement agreement, which is entitled the Stipulation Re:
Settlement of Class and Collective Actions, as well as other public documents filed with regard
to this matter can be inspected in the Office of the Court Clerk (see below). This settlement has

been preliminary approved by the Court.

California Class Members who do not opt out of the settlement will remain subject
to the judgment and be precluded from bringing similar claims against Yelp or any of its
affiliates in the future. Specifically, all California Class Members who do not opt out of the
settlement, whether they submit claim forms or not, will be precluded from bringing any
future claims concerning claims for unpaid regular or premium overtime or other
premium wages and/or remedies relating to meal/rest period, recordkeeping, and timing of
wage payment requirements.

Only those individuals who remain Members of the California Class will be eligible
to participate in this settlement and receive payment under this agreement, and only those
individuals who submit qualifying claim forms will receive payment. If you do not
complete and timely submit the Claim Form, you will still be included in the California
Class, but not receive a settlement payment. Those California Class Members who opt out
of the settlement will neither be eligible to receive any payment pursuant to this settlement,

#### What Will I get Under the Settlement If I file a Claim?

17 Under the settlement, each California Class Member who submits a Claim Form will 18 receive a minimum amount per each qualifying week worked between March 29, 2007 and 19 December 31, 2011. Currently, your estimated settlement payment is at least *[MERGE]* 20 because we estimate that you worked [MERGE] qualifying weeks during the period between 21 March 29, 2007 and December 31, 2011 in California, i.e., you worked that many weeks in one 22 of the covered positions during this time frame. Again, if less than half of the money available 23 for California settlement payments is claimed, however, your settlement sum will increase to an 24 amount higher than that listed above.

#### C. Is My Settlement Payment Taxed?

A portion of any payment made to you under the settlement will be subject to required wage withholdings and deductions, and as a result, the amount you receive will be less than the gross amount listed above. Yelp will report thirty-three percent (33%) of this payment to

1 relevant government entities as a wage payment, and will report the remaining sixty-seven 2 percent (67%) as a non-wage payment. Yelp reserves the right to make any required 3 withholdings or deductions as required by applicable law, and California Class Members should 4 be advised that Yelp will report any payments made pursuant to this agreement to the Internal 5 Revenue Service and other relevant government entities (if any) as required by law. 6 Each California Class Member will be solely responsible for reporting any payment received 7 pursuant to this settlement and for paying any taxes associated with the same. Neither the Class 8 Representatives, Class Counsel, nor Yelp makes any representations concerning the tax 9 consequences of this settlement or your participation in it. If you have any questions about the 10 tax consequences of the payments you may receive under the settlement, you should consult your 11 tax advisor.

#### D. What if I think I worked More Workweeks?

If you believe the number of qualifying work weeks listed above in Section III.B is
inaccurate, please contact the Settlement Administrator or Class Counsel immediately and
provide them with any supporting documentation in support of your view. Remember, however,
that the only weeks that qualify are weeks in which you worked in one of the covered positions
during the pertinent time frame. So, for example, work in other positions does not count and
work performed in 2012 and beyond does not count.

#### E. How Much Will Class Counsel Be Paid in Attorneys' Fees?

20 Class Counsel will request that the Court award them attorneys' fees up to 25% of the 21 maximum settlement amount that Yelp could pay, or \$312,500. This request will be subject to 22 review and approval by the Court. Yelp has agreed not to oppose this request. Class Counsel 23 will also seek reimbursement of up to \$10,000 in out-of-pocket expenses incurred in this case, 24 which will also be subject the Court's approval. Any amounts approved by the Court will 25 constitute full payment for all legal fees of Class Counsel in the action, including any work they 26 do in the future in connection with the Settlement. In the event any amount of the requested fees 27 or costs are not approved by the Court, the unawarded amount will revert to the maximum 28 settlement payout to class members.

## What Deductions Will Be Made From the Settlement Amount?

The settlement additionally provides that deductions from the Maximum Settlement 3 Amount will be made for (1) reimbursement of settlement administration expenses not to exceed 4 \$25,000; (2) enhancement payments of \$5,000 to each of the three Plaintiffs for a total of 5 \$15,000; (3) payment of \$7,500 to the California Labor and Workforce Development Agency. 6 These estimated payments are all subject to the approval of the Court.

#### IV. THE PEOPLE RECEIVING THIS NOTICE

8 The Class Representatives have brought this action as a class and collective action. In 9 class and collective actions, one or more persons bring claims on behalf of themselves and others 10 who purportedly are in similar situations or have similar claims. In other words, the Class 11 Representatives are seeking to represent those who are purportedly similarly situated and thus 12 may also have similar or related claims. ### III. DESCRIPTION OF THE SETTLEMENT

#### A. Summary of Settlement

On behalf of both a National and a California class, Plaintiffs Larkin and Tijerino have
reached a voluntary settlement agreement with Yelp. The total maximum amount of the
consolidated settlement is \$1,250,000, with approximately one-third of that amount allocated to
the resolution of the claims of the National Settlement Class.

Through this settlement, neither Yelp nor its employees have admitted any liability or
wrongdoing. A full copy of the settlement agreement, which is entitled the Stipulation Re:
Settlement of Class and Collective Actions, as well as other public documents filed with regard
to this matter can be inspected in the Office of the Court Clerk (see below). This settlement has
been preliminary approved by the Court.

Only those individuals who opt-in by submitting a qualifying National Opt In and
Claim Form will remain Members of the National Class and will be eligible to participate in
this settlement and receive payment under this agreement, and only those individuals who
submit qualifying claim forms will receive payment. If you do not complete and timely
submit the National Opt In and Claim Form, you will not be included in the National Class.
If you do not opt in to the settlement, you will neither be eligible to receive any payment

#### E. How Much Will Class Counsel Be Paid in Attorneys' Fees?

4 Class Counsel will request that the Court award them attorneys' fees up to 25% of the 5 maximum settlement amount that Yelp could pay, or \$312,500. This request will be subject to 6 review and approval by the Court. Yelp has agreed not to oppose this request. Class Counsel 7 will also seek reimbursement of up to \$10,000 in out-of-pocket expenses incurred in this case, 8 which will also be subject the Court's approval. Any amounts approved by the Court will 9 constitute full payment for all legal fees of Class Counsel in the action, including any work they 10 do in the future in connection with the Settlement. 10 filed, and must be postmarked, no later than ten days following the filing of Class Counsel's
11 motion for an award of attorneys' fees and costs.

12

#### VI. RELEASE OF CLAIMS

13 All Members of the National Class who opt in to the settlement shall be subject to 14 the judgment connected with this action and associated settlement. This means they shall be 15 deemed to have forever released and discharged Yelp and all its past and present affiliates, 16 directors, officers, employees, partners, members, principals, agents, insurers, co-insurers, re-17 insurers, shareholders, attorneys, and personal or legal Representatives from any demands, rights, 18 liabilities, and causes of action of every nature and description whatsoever, including without 19 limitation statutory, constitutional, contractual or common law claims, whether known or 20 unknown, whether or not concealed or hidden, whether arising under federal or state law, against 21 Yelp, its affiliates, employees, agents, or any of them, including without limitation claims for 22 wages, damages, unpaid costs, penalties, liquidated damages, punitive damages, interest, attorney 23 fees, litigation costs, restitution, or equitable relief, that accrued through December 31, 2011 as a 24 result of the National Class Member's employment as an Account Executive in any state other 25 than California for Yelp, based on the following categories of claims or allegations: (a) any and 26 all claims for (i) failure to pay wages for work performed in excess of eight hours in a day or 27 forty hours in a week, regular; and/or (ii) failure to pay regular or overtime wages, failure to pay 28 minimum wages, failure to comply with payroll or wage record-keeping or itemization

requirements; (b) any and all claims alleging statutory violations arising from the same categories
of allegations set forth above in (a), including without limitation claims under the Fair Labor
Standards Act ("FLSA"), the Portal to Portal Act, and pertinent state laws; (c) any and all claims
for penalties or liquidated damages or other available remedies arising from the categories of
allegations set forth above in (a) and (b; and (d) any and all claims for interest, costs, or attorney
fees arising from the categories of allegations set forth above in (a) and (b) and (e) to the extent
not covered by the above, any and all claims pled in the Litigation.

#### VII. HEARING ON SETTLEMENT

9 Following a hearing on or about [INSERT DATE], pursuant to the procedures for 10 the approval of class actions and Rule 23 of the Federal Rules of Civil Procedure and the 11 procedures for collective actions under the FLSA, the Court granted preliminary approval for the 12 settlement of this matter as a class and collective action and scheduled a hearing on final approval 13 for [**INSERT DATE**]. Late written objections will not be valid.

Again, attendance at this hearing is completely optional; attendance at the

23 hearing is <u>not</u> required to participate in the settlement or to opt out of the lawsuit.

UDGMENT Case No. 11-CV-01503 EMC This matter came on for hearing upon the joint application of the Settling Parties for approval of the settlement set forth in the Stipulation of Settlement (the "Stipulation"). Due and adequate notice having been given to the California Class and the National Class, and the Court having considered the Stipulation, all papers filed and proceedings had herein, and all oral and written comments received regarding the proposed settlement, and having reviewed the record in this Litigation, and good cause appearing,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:

1. The Court, for purposes of this Judgment, adopts all defined
 terms as set forth in the Stipulation Re: Settlement of Class and Collective Actions
 ("Stipulation") filed in this case.

2. The Court has jurisdiction over the subject matter of the
 Litigation and the Class Representatives, the Members of the California Settlement
 Class, the Members of the National Settlement Class, and Yelp.

The Court finds that the distribution of the California Notice and 3. 16 the National Notice as provided for in the Order Granting Preliminary Approval 17 and Settlement Hearing, constituted the best notice practicable under the 18 circumstances to all Persons within the definition of the California Class and 19 National Class, and fully met the requirements of due process under the United 20 States Constitution and California law. Based on evidence and other material 21 submitted in conjunction with the Settlement Hearing, the actual notices to the 22 California Class and National Class were adequate. The Court further finds that 23 Yelp has satisfied the requirements of notice to pertinent government agencies set 24 forth in the federal Class Action Fairness Act of 2005. 25

4. The Court finds that the instant Litigation presented a good faith
dispute over the payment of wages, and the Court finds in favor of settlement
approval.

5. The Court approves the settlement of the above-captioned action, as set forth in the Stipulation, each of the releases and other terms, as fair, just, reasonable, and adequate as to the Settling Parties. The Settling Parties are directed to perform in accordance with the terms set forth in the Stipulation.

6. Except as to any individual claim of those Persons (identified in Attachment A hereto) who have validly and timely requested exclusion from the California Settlement Class, all of the California Released Claims are dismissed with prejudice as to Class Representatives Justin Larkin and Anthony Tijerino, and the other Members of the California Class. The Settling Parties are to bear their own costs, except as otherwise provided in the Stipulation.

7. All of the National Released Claims are dismissed with
 prejudice as to the Class Representatives and the other Members of the National
 Settlement Class. The Settling Parties are to bear their own costs, except as
 otherwise provided in the Stipulation.

8. Solely for purposes of effectuating this settlement, this Court
has certified a class of all Members of the California Settlement Class, as that term
is defined in and by the terms of the Stipulation, and the Court deems this definition
sufficient for purposes of due process and Rule 23.

With respect to the California Settlement Class and for purposes 9 19 of approving this settlement only, this Court finds and concludes that: (a) the 20 Members of the California Settlement Class are ascertainable and so numerous that 21 joinder of all members is impracticable; (b) there are questions of law or fact 22 common to the California Settlement Class, and there is a well-defined community 23 of interest among Members of the California Settlement Class with respect to the 24 subject matter of the Litigation; (c) the claims of the Class Representatives are 25 typical of the claims of the Members of the California Settlement Class; (d) the 26 Class Representatives have fairly and adequately protected the interests of the 27 California Members of the Settlement Class; (e) a class action is superior to other 28

available methods for an efficient adjudication of this controversy; and (f) the counsel of record for the Class Representatives, *i.e.*, Class Counsel, are qualified to serve as counsel for the plaintiff in his individual and representative capacities and for the California Settlement Class.

10. Solely for purposes of effectuating this settlement, this Court
has certified a collective action class of all Members of the National Settlement
Class, as that term is defined in and by the terms of the Stipulation, and the Court
deems this definition sufficient for purposes of due process and 29 U.S.C. § 216(b).

9 11. With respect to the National Settlement Class and for purposes
of approving this settlement only, this Court finds and concludes that: the National
Settlement Class meets the requirements for certification as a collective action class
under 29 U.S.C. § 216(b) because the National Settlement Class Members are
similarly situated.

14 12. By this Judgment, the Class Representatives shall release,
relinquish, and discharge, and each of the California Settlement Class Members
shall be deemed to have, and by operation of the Judgment shall have, fully, finally,
and forever released, relinquished, and discharged all California Released Claims
(including Unknown Claims).

By this Judgment, the Class Representatives shall release,

14. This Litigation is hereby dismissed with prejudice.

15. Neither the Stipulation nor the settlement contained therein, nor
any act performed or document executed pursuant to or in furtherance of the
Stipulation or the settlement: (i) is or may be deemed to be or may be used as an
admission of, or evidence of, the validity of any California Released Claim or

National Released Claim, or of any wrongdoing or liability of Yelp; or (ii) is or 1 may be deemed to be or may be used as an admission of, or evidence of, any fault 2 or omission of Yelp in any civil, criminal, or administrative proceeding in any 3 court, administrative agency, or other tribunal. In the event that the Effective Date 4 does not occur, Yelp shall not be estopped or otherwise precluded from contesting 5 class or collective action certification in the Litigation on any grounds. Yelp may 6 file the Stipulation and/or the Judgment from this Litigation in any other action that 7 may be brought against them in order to support a defense or counterclaim based on 8 principles of res judicata, collateral estoppel, release, good faith settlement, 9 judgment bar, or reduction or any theory of claim preclusion or issue preclusion or 10 similar defense or counterclaim. 11

The only California Settlement Class Members entitled to 16. 12 payment pursuant to this Judgment are California Participating Claimants, and the 13 only National Settlement Class Members entitled to payment are National 14 Participating Claimants. Neither the Stipulation nor this Judgment will result in the 15 creation of any unpaid residue or residual, and any funds that would have been paid 16 to California Class Members and National Class Members had they become 17 California Participating Claimants and National Participating Claimants that are not 18 claimed shall remain the property of Yelp. 19

Yelp has agreed to pay Class Counsel their reasonable attorney 17. 20 fees in this matter in the total combined, gross amount of \$312,500 as well as 21 certain allowable costs in this matter up to the gross amount of \$10,000, and Yelp 22 has agreed to pay an enhancement award of \$5,000 to each of the Class 23 Representatives to reimburse them for their unique services and execution of 24 general releases. The Court finds that these agreements are fair and reasonable. 25 Yelp is directed to make such payments in accordance with the terms of the 26 Stipulation. 27

18. The Court reserves exclusive and continuing jurisdiction over
