Pursuant to Rule 16(b) of the Federal Rules of Civil Procedure, the parties attended a Case Management Conference on February 2, 2012. After considering the Joint Case Management Statement submitted by the parties and consulting with the attorneys of record for the parties and good cause appearing, IT IS HEREBY ORDERED THAT:

1. ALTERNATIVE DISPUTE RESOLUTION.

EARLY NEUTRAL EVALUATION. This matter is referred to early neutral evaluation to be completed within 120 days of the issuance of this order. The parties shall promptly notify the Court whether the case is resolved at the conference.

2. DISCOVERY.

1           On or before December 14, 2012, all non-expert discovery shall be completed by the parties.  
2           Discovery shall be limited as follows: (a) ten (10) non-expert depositions per party; (b) thirty-five  
3           (35) interrogatories per party, including all discrete subparts; (c) a reasonable number of requests  
4           for production of documents or for inspection per party; and (d) a reasonable number of requests for  
5           admission per party.

6           3.       EXPERT WITNESSES. On or before January 31, 2013, all expert discovery shall be  
7           completed by the parties

8           4.       FURTHER CASE MANAGEMENT CONFERENCE. A Further Case Management  
9           Conference shall be held on **January 10, 2013 at 10:00 a.m.** in Courtroom 3, 17th Floor, United  
10          States Courthouse, 450 Golden Gate Avenue, San Francisco, California. The parties shall file a  
11          Joint Case Management Statement at least one week prior to the Conference.

12          5.       PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to  
13          Civil Local Rule 7. All pretrial motions shall be heard no later than February 7, 2013.

14          6.       PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and  
15          confer to discuss preparation of a joint pretrial statement, and on or before March 14, 2013 counsel  
16          shall file a Joint Pretrial Statement.

17          7.       PRETRIAL CONFERENCE. The final pretrial conference will be held on **March**  
18          **28, 2013 at 10:00 a.m.**, in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate  
19          Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend  
20          personally.

21          8.       TRIAL DATE. Trial shall commence on **April 8, 2013 at 9:00 a.m.**, in Courtroom  
22          3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco, California.
