1 **ORDER REGARDING SCHEDULING**

2 **IT IS HEREBY ORDERED** that the following schedule should govern discovery and pre-trial  
3 proceedings in this case until further Order of the Court:

- 4 1. The parties may start serving requests for production of documents and interrogatories on  
5 July 1, 2013.
- 6 2. Except as to requests for admissions for authentication and admissibility of trial exhibits, fact  
7 discovery shall be completed on October 20, 2014.
- 8 4. Plaintiffs shall file motions for class certification and any supporting expert declarations on  
9 or before March 17, 2014. Plaintiffs shall make any class certification experts available for  
10 deposition on or before April 21, 2014. Defendants shall file memoranda and expert  
11 declarations in opposition to Plaintiffs' class certification motions on or before May 19,  
12 2014. Defendants shall make any class certification experts available for deposition on or  
13 before June 20, 2014. Plaintiffs shall file reply memoranda in further support of their class  
14 certification motions and any rebuttal declarations from previously-disclosed experts on or  
15 before July 21, 2014.
- 16 5. The parties shall serve their respective expert reports on liability and damages on or before  
17 December 19, 2014. The parties shall make their respective experts available for deposition  
18 on or before February 23, 2015. The parties shall serve any rebuttal expert reports on or  
19 before April 13, 2015. Following service of rebuttal expert reports, the parties shall have  
20 opportunity to take expert depositions, solely limited to new matters raised in the rebuttal  
21 reports, to be completed on or before May 1, 2013.
- 22 6. The parties shall file any summary judgment motions and motions to exclude expert  
23 testimony under *Daubert* on or before May 29, 2015. Opposition briefs shall be filed on or  
24 before July 17, 2015, and reply briefs shall be filed on or before August 21, 2015.
- 25 7. The Pretrial Conference and trial will be scheduled at a time convenient for the Court.
