1 Pursuant to L.R. 6-2, Plaintiffs Tammie Davis, Valeria Lletget, and Stefani Concepcion

4 **RECITALS**

5 **WHEREAS**, the Court has scheduled a Case Management Conference for March 22, 2013
6 at 1:30 p.m., in Courtroom 11 on the 19th floor of the Federal Building, 450 Golden Gate
7 Avenue, San Francisco, California, and has ordered a joint case management statement due on or
8 before March 15, 2013 [Docket No. 67];

9 **WHEREAS**, the Parties have agreed in principle to settle the instant action, and are close to
10 executing a settlement agreement; and

11 **WHEREAS**, Plaintiffs will file a motion for preliminary approval of the Parties’ settlement
12 agreement on or before March 29, 2013;

14 Now, therefore, the Parties stipulate and respectfully request that the Court order as
15 follows:

16 1. That the Case Management Conference scheduled for March 22, 2013 will be
17 vacated and that the Parties are not required to file a joint case management statement, due to the
18 Parties’ imminent settlement agreement.


