2 It is further understood and agreed to by the parties that the October 9, 2012 PRETRIAL
3 CONFERENCE date, the October 18, 2012 JURY SELECTION date, and the October 22, 2012
4 JURY TRIAL date **shall remain the same** as originally ordered by this Court in the September
5 12, 2011 Pretrial Preparation Order (Document No. 24).

6 Good cause exists for this Stipulation as the parties have conferred and remain reasonably
7 optimistic as to the upcoming June 13, 2012 Mandatory Settlement Conference and, as such, do
8 not wish to incur the additional expense of preparing and finalizing expert reports as well as the
9 work and expense that is required to prepare and finalize rebuttal reports until after the June 13,
10 2012 Mandatory Settlement Conference. The parties believe that the preparation of expert
11 reports and rebuttals prior to and during the Mandatory Settlement Conference may result in an
12 unnecessary waste of resources that may be better spent on attempting to resolve this case.
